5. Approval of Minutes of January 13, 2011.

Supervisors Jensen and Thomas moved the approval of the minutes of January 13, 2011 as presented. ADOPTED as presented by acclamation.

10.A. Wisconsin Counties Association 2009 –2010 Annual Report.

Chair Podzilni introduced the 8 minute video that highlights the 75th Anniversary of the Wisconsin Counties Association. More about the WCA can be found at http://www.wicounties.org/

10.B. ADRC Steering Committee Recommended Plan.

Supervisor Thomas introduced Jennifer Thompson, Long Term Support Division Manager for Rock County and the Lead staff in the development of the Rock County Aging and Disability Resource Center Planning Committee's Recommended Plan.

Ms. Thompson presented. ADRC's offer the general public a single point of entry for information and Assistance on issues affecting elderly individuals with physical and/or developmental disabilities, individuals with mental illness or their families. They should be designed to be welcoming and convenient places to get information, advice and access to a wide variety of services and programs. The staff members assist people to understand their options and aid in applying for programs and benefits.

The ADRC (Aging and Disability Resource Center) provides information and assistance as well as screens for managed care eligibility for the elderly, people with physical disabilities, and people with Developmental Disabilities. ADRC's also provide information and assistance to people with Mental Health and Substance Abuse issues.

Rock County developed this ADRC plan because of the State initiative to implement managed care (a.k.a. Family Care) Statewide and Rock County is slated to implement January 1, 2012. All Counties with Managed Care have ADRC's which link eligible individuals to the Managed Care Organization. The ADRC plan was developed in conjunction with the Human Services Division, the Council on Aging, and the DD Board.

The current location of the Rock County ADRC is at the Job Center located at 1900 Center Avenue, Janesville. It is co-located with Economic Support and is accessible, on the bus line and has adequate parking. The ADRC will have an operating board appointed by the County Board Chair and confirmed by the County Board. This plan recommends a 15-member board of four elderly representatives, one physically disabled representative, one developmentally disabled representative, and nine ethnic/economically diverse representatives of the Rock County population.

The organizational structure will have a staff of 19: 1 Director, 2 Supervisors, 1 Reception, 9 Information & Assistance, 2 Disability Benefit Specialist, 2 Elderly Benefit Specialist and 2 Economic Support Specialist. The next steps to opening the Rock County ADRC slated for November 1, 2011 includes bringing forth a Resolution to approve the application. A director will be hired, policy and procedure will be developed, building modifications will be made and staff trained and put in place.
