### Approval of Minutes of June 28, 2012.

Supervisors Jensen and Bostwick moved the approval of the minutes of June 28, 2012 as presented. ADOPTED as presented by acclamation.

### Citizen Participation, Communications and Announcements.

Captain Brent DeRemer invited Board Members to attend the court room security training on July 27th, 2012. There will be two sessions offered: 9:00 am in court room D and 1:00 pm in court room E. The sessions were broken down to two time frames to allow as many people as possible to attend from the courthouse. This training is open to anyone at the courthouse and will consist of different levels of threats that may occur in a courthouse/courtroom setting. Dane County Sheriff's Office will be conducting this training. This training is highly recommended for all courthouse personnel and this will help prepare us for any acts of aggression or incidents that may occur. Please feel free to contact me with any questions. I am looking forward to seeing everyone on July 27th, 2012.

Ronnie E. Thomas, Janesville, thanked the Board for the induction of him and his late wife into the Rock County Hall of Honor.

Jon Swets, Avalon, addressed the Board on agenda item 12.E. Mr. Swets is in favor of leaving the Curve on County Highway M as it is and believes that the new configuration adds levels of safety concerns that were never addressed with the citizens, especially the farmers and trucks who have traveled this curve for several years. He encouraged the Board to leave the curve configured as is and just lay new pavement and replace guardrails.

Dr. Margaret Pulera, Darien, addressed the Board on agenda item 12.E. Dr. Pulera explained that she sat on the Plan Commission in Richmond Township for 18 years and largely assisted in the writing of the 2010 Comp plan for the Township, hoping to lend credibility to her case with the Board in regards to the concerns she has brought forward relating to the Curve on County M. An updated petition including seventy-five signatures was presented to Chair Podzilni asking to leave existing roadways the way they are configured today. Dr. Pulera also presented all County Board members with color photos and layouts explaining in detail the safety concerns of the proposed new design, in addition to a letter stating eight reasons she is encouraging the board to vote in favor of the Resolution tonight to leave the road configured as is.

Justin Snyder, 5303 N. County line Road, addressed the Board on agenda item 12.E. He concurred with the previous speakers, adding that there would also be concerns of grade change on the new design, causing concerns of load change for those hauling crops, etc. Mr. Snyder also cited concerns of the new guardrail configuration and questioned its safety. He asked the Board to support the resolution before them tonight.

Supervisor Kraft, Planning Director Paul Benjamin, Assemblyman Evan Wynn and leaders from the Edgerton Community announced the award of a large CDBG grant which the Board will accept tonight under item 12.D.4. The Rock County Planning Department submitted a Community Development Block Grant for up to \$500,000 several months ago. On July 3<sup>rd</sup>, they

received an award letter from the Department of Administration stating that they were to be awarded \$381,000 for the project at the Edgerton Community Outreach Building. This building has historic value in downtown Edgerton and currently provides services to the needy in the community. Additional fundraising will be necessary to rehabilitate the entire building, but this award makes the project a reality that feels quite rewarding to the residents of Edgerton.

Chair Podzilni announced that there are three Supervisors with July Birthdays: Collins, Yoss and Knudson. Happy Birthday to all. He also informed the Board that past Supervisor Ron Combs has experienced some setbacks to his health lately and announced that a get well card was circulating for them to sign.

Randy Terronez, Assistant to the County Administrator, introduced the Cullen Interns. This year's interns are Natalie Arriaga and Connor Sheedy from Craig High School, and Felicia Arambula and John Muetz from Parker High School. Arambula is working in the office of Rep. Andy Jorgensen, D-Fort Atkinson, Arriaga with Sen. Bob Jauch, D-Poplar; Muetz with Sen. Neal Kedzie, R-Elkhorn; and Sheedy with Sen. Dale Schultz, R-Richland Center. The program, entering its ninth consecutive year, is wholly funded by Tim and Barb Cullen of Janesville Township. Tim is a Democratic state senator. The interns have spent the day with Rock County Administration touring and meeting with leaders in County Government.

#### 10.A. Rock County Economic Development Update – James Otterstein.

James Otterstein, Economic Development Specialist, introduced "Rock County Ready", a Media and Public Relations Campaign of the Rock County Development Alliance. The Alliance, which is anchored by the Rock County ED Agency, is a network of Rock County economic development interests that began in 2001 in partnership with Beloit, Janesville and Alliant Energy. Through the Alliance, these partners share expertise, pool marketing funding and leverage networking assets. As the County prepared to recover from the loss of GM and the impacts of the Great Recession in summer 2009, it was evident that the Alliance lacked sufficient resources. This is where Rock County 5.0 stepped forward: providing the platform to capitalize and leverage available public/private resources.

The Rock County Ready campaign (<a href="www.RockCountyReady.com">www.RockCountyReady.com</a>), which financed by Rock County 5.0, is designed to promote positive, relevant news; address stereotypes within the community; and inform or educate potential businesses and investors about development opportunities throughout Rock County. The campaign is using enhanced/expanded messaging to reach various targets. After walking the Board through the details of the campaign, including a reference to the prepackaged thumb drive offering, Mr. Otterstein noted that this information was housed online within the Alliance's dedicated online Media Room (<a href="www.rockcountyalliance.com">www.rockcountyalliance.com</a>).

Mr. Otterstein asked Board members to stay informed, be engaged and most importantly, serve as ambassadors of optimism. Additionally, Board members could assist by serving as communication conduits to share and exchange with their constituents, as well as act as a source of business leads. He closed by noting that additional information about the campaign, the market and the County's recovery/repositioning plan were available online.

12.E. Resolution to Stop the New Design of the Curve on Rock County M and Rock-Walworth
County Line Road Intersection in the Town of Johnstown.
Resolution No. 12-7A-078

NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors in session this 12<sup>th</sup> day of July, 2012 that they hereby overturn the decision of the Public Works Committee as it relates to the design change on County M and the Rock-Walworth County Line Road intersection located in the Town of Johnstown; and,

BE IT FURTHER RESOLVED that they order County M to be repaired as it currently exists without any design change.

Much discussion took place and multiple Supervisors addressed questions and concerns to Public Works Director, Ben Coopman and two engineers present to explain why the configuration has changes to the current configuration. The professional engineers cited DOT standards and explained in detail, the proposed changes to the roadway. The Department of Transportation prefers 90 degree site distance, and accepts nothing less than 60 degrees. The current configuration has an acute angle of approximately 30 degrees. The intersection sight distance of the existing curve is 495 feet and has a recommended speed of 45 mph. The intersection sight distance of the proposed intersection in the same direction is 600 feet and has a recommended speed limit of 50 mph.

The DOT has recommended that all 3-legged Y-intersections be replaced. Examination of the existing guard rail shows extreme wear and damage, suggesting multiple impacts. Mr. Coopman stated he's heard of seven documented crashes at this site in the past 15 years. He also indicated that the new design is safer for motorcycles and those leaving the roadway as well as reducing the opposing traffic conflict points from 27 to 9 under the new configuration. Corporation Counsel, Jerry Long, also explained to the Board members that past history is not considered an indication of future performance from a liability standpoint, and reminded them that standards at the Federal level are handed down and litigated minded people could sue for negligence. For example, an accident where there was intentional failure to meet sight line could be considered negligence. After more discussion, Supervisor Wopat called the question.
