# 10.A. <u>Report - Rock County Justice Center Jail Renovation & Expansion Project Progress Report - The Samuels Group</u>

The Progress Report covered a Project overview of the buildings of Pinehurst, Emergency Services Storage Building, Boat Storage building relocation, Soils Remediation, Jail Addition and general renovation.

At Pinehurst, the storm system and downspouts have been installed to redirect water away from the foundation; site grading at the building perimeter was completed; sidewalk modifications were made to add a curb at the stairs; Tunnel removal and wall infill has been completed and mortar re-pointing and roof tile repairs were made. Sealants at the rooftop perimeter stone were also done.

The Emergency Services Vehicle Storage Building has 6,000 sq. ft. of storage for emergency services vehicle storage. The building is a pre-engineered steel framed, metal building with 12 overhead doors for drive thru access.

The relocation of the storage building was completed. Some repairs were done but the building was placed on a concrete pad, in lieu of leaving dirt. Soils remediation for the project were bid as a unit price to only remove bad soils and replace with an engineered fill. Psi, a third party testing firm found the top soil did not have baring capacity and therefore the unit price went from \$287,000 to \$305,000. While that sounds like an increase to the project, remediating in this format saved the project \$198,000, so we are well within budget at this time.

In the building addition, foundations and slab on grade are complete; CMU walls and MEP rough in is up; Precast exterior walls will begin early November, followed by metal trusses and roof deck mid-month. The building should be enclosed by the end of November and the addition is expected to be complete by June, 2011.

On the general renovation side, there is the Fire Alarm System, the Security System, HVAC Controls, the Medical Area and the Bureau of Identification as shown in the floor plan diagram. This area is scheduled to run from September 2010 to November 2011. A final layer of asphalt will be placed sometime in the fall of 2011 to complete this phase.

12.E. <u>Authorizing the Redemption of the 2011 Maturity of the Rock County \$5,425,000 General</u>
Obligation Promissory Notes Dated July 15, 2002. Resolution No. 10-10B-169

NOW, THEREFORE, BE IT RESOLVED, by the Rock County Board of Supervisors that:

Section 1. Authorization of the Bond Redemption. For the purpose of paying the cost of the Note Redemption, the County shall use funds on hand in the amount of \$700.000 to redeem the 2011 maturity of the 2002 Notes on March 1, 2011.

Section 2. Redemption of the 2002 Notes. The County hereby calls the 2002 Notes due on September 1, 2011 for redemption on March 1, 2011. The County hereby directs the County Clerk to cause a notice of redemption, in substantially the form attached hereto as Exhibit A, to be given, no more than sixty days and no less than thirty days prior to March 1, 2011, to the Depository Trust Company, New York, New York, the securities depository for the 2002 Notes.

Section 3. Conflicting Resolutions; Severability; Effective Date. All prior resolutions, rules or other actions of the County or any parts thereof in conflict with the provisions hereof shall be and the same are hereby rescinded insofar as they may so conflict. In the event that any one or more provisions hereof shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.
