Mr. VanDeBogart indicated that the Beloit City Council is in full support of moving ahead with the CTH G Mega Project Agreements with the County and the WI DOT. He also noted that the City Engineer, Mike Flesch was present should they have additional questions.

Randy Thompson, Edgerton, invited the Board to "Focus on Agriculture" at Larson Acres on Wednesday, June 27 from 10am to 1:30pm. Tour of the farm, economic impact discussion, nutrient management discussion, OSHA and Immigration Reform as well as Lunch will be the focus of the day. On behalf of the Rock County Farm Bureau Federation, he hopes they'll attend.

Margaret L. Pulera, MD, of Darien, addressed they Board in opposition to eliminating the existing connector at County Highway M and Rock-Walworth County Line Road. She presented the Board a petition signed by sixty-two area residents who feel that the existing connecting roadways on the curve of County M that connect to Rock-Walworth County Line Road have an excellent safety record of use by local citizens and farmers, and believe they should stay the way they are. Dr. Pulera also cited financial savings to repaving and installing to guard rail, vs. changing the road layout completely. She also cited statistical information on accident rates and encouraged Public Works Director, Ben Coopman and the Board of Supervisors to accommodate this request.
