<u>Discussion and Possible Approval of Purchase of Services agreement with Grant County Child Support</u> Ms. Baker Ellis handed around a copy of the contract with Grant County. She explained that, due to newer employees and an employee who is going to be out for an extended period of time, they are requesting to have budgeted funds used for Grant County to help with financial services for the KIDS data system. The cost will be approximately \$1,600 per month, will start around April 1st and could last until August 2016.

Supervisor Knudson moved approval to have Grant County help in this capacity, second by Supervisor Fell. ADOPTED.

<u>Committee Requests and Motions.</u> Ms. Baker Ellis informed the Committee that Child Support will be changing their process server back to Gregg Investigations.

Mr. Terronez introduced Lisa Wallenkamp to the Committee and explained she is the Lead Medicolegal Investigator for the Medical Examiner's Office. Ms. Wallenkamp gave a brief description of her background with Dane and Rock Counties Medical Examiner Offices.
