Supervisor Wiedenfeld asked why the bill for Equitably Shared Funds in amount of \$3,525.62 was driving a negative amount. Ms. Michaelis said that this was her error. **Recognize Shelley Sturdevant-Recipient of the State Victim Advocate of the Year Award**

Mr. O'Leary introduced Shelley Sturdevant to the committee. Shelley has won the 2015 Crime Victim Advocate of the year. She was nominated by Assistant District Attorney Rich Sullivan. The District Attorney will be doing a press release in the near future. Mr. O'Leary explained several of Ms. Sturdevant's accomplishments. Supervisor Brill asked if Mr. O'Leary could present this to the County Board on Thursday, July 9<sup>th</sup>. Yes, we will add this to the County Board agenda.

**Set Future Meeting Dates for Remainder of the Year.** It was brought to the committee's attention that the first scheduled meeting in September falls on Labor Day, Sept 7<sup>th</sup>. The second meeting in December falls the week of Christmas on Dec 21<sup>st</sup>. It was asked if they would like to reschedule these meetings for different dates. The committee agreed that they will make a decision the week before both dates to see what is on the agenda. If not much, they may decide to cancel. This agenda item should be tabled for a closer meeting.

**Committee Requests and Motions.** Supervisor Wiedenfeld asked about a fall tour of the jail. Ms. Michaelis asked the frequency of the jail visits, once or twice a year. It is believed that the committee has already toured the jail once this year. Supervisor Brill asked that the previous tour dates be brought back to the next meeting.

**Adjournment.** Supervisor Wiedenfeld moved adjournment at 4:20 P.M., second by Supervisor Knudson. ADOPTED.
