

PUBLIC SAFETY & JUSTICE COMMITTEE Minutes – October 1, 2018

<u>Call to Order</u>. Chair Beaver called the meeting of the Public Safety and Justice Committee to order at 4:00 P.M. in Conference Room N-1, Fifth Floor, Courthouse East.

Adoption of Agenda. Supervisor Owens moved approval of the agenda as presented, second by Supervisor Knudson. ADOPTED.

<u>Citizen Participation, Communications, Announcement, Information.</u> Judy Vaughn and David Vaughn asked the Committee to not remove the Correctional Officers from protective occupation status.

Sheriff Spoden said he wanted the Committee to understand this is not a law and the County is not mandated to remove the Correctional Officers from protective occupation status. He said he feels this is being done for budgetary reasons, and this is a policy choice. Sheriff Spoden added Correctional Officers have received protective occupation status for 40 years, he sees no reason to change this, and there is no penalty if this is not done.

Carla Quirk said, as president of the AFSCME, she opposes removing Correctional Officers from protective occupation status, this is not a requirement of ACT 10, and there are other ways to balance the budget.

Roger Palek, attorney with WPPA, said this is not a requirement and feels this is a political decision. He asked the Committee to not make a decision based on what Corporation Counsel or the County Administrator are saying as he feels this is a financial decision.

Bob Buchanan said the AFSCME 1077 stand in solidarity with the Correctional Officers and asked the Committee not to go forward with this.

Adoption of Minutes. Supervisor Knudson moved approval of the minutes of September 10, 2018 as presented, second by Supervisor Owens. ADOPTED.

Supervisor Fell moved approval of the above resolution, second by Supervisor Knudson.

Supervisor Knudson said he is opposed to the removal of the protective occupation status. He said at one time he had spent a day at the Jail and was shocked at what he saw, and the Correctional Officers have nothing but his respect for what they go through.

Supervisor Owens said while he was in the Military Police he spent time at Waupun Correctional Institution during the uprising and he is in favor of keeping the protective occupation status for the Correctional Officers.

Supervisor Fell said he is in support of keeping the protective occupation status for the Correctional Officers.

Supervisor Hawes said she echoes everything her fellow Supervisors have said and she appreciates what Correctional Officers do on a daily basis.

Chair Beaver said she supports the protective occupation status for the Correctional Officers. She said she had a friend who worked in the Jail for a short time and could not handle it.
