ABOLISHING THE OFFICE OF THE CORONER AND ESTABLISHING A MEDICAL EXAMINER SYSTEM

2	WHEREAS, the County Board previously abolished the Office of the Coroner by Resolution 06-8A-069, this resolution was later rescinded by Resolution 08-12A-170; and,
5	WHEREAS, Article VI, Section 4 of the Wisconsin Constitution provides for the establishment of the medical examiner system in lieu of a coroner; and,
8	WHEREAS, s 59 34, Wis Stats, also provides for the establishment of a medical examiner by the County Board; and,
1	WHEREAS, it may be possible to establish a medical examiner system at a cost comparable to a coroner's office; and,
	WHEREAS, adopting a medical examiner system would allow the County Board more flexibility to determine the structure and staffing of the office.
L6 L7	NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this day of, 2010 does hereby abolish the position of the coroner and establish a medical examiner system, effective January 3, 2011.
