<u>Adoption of Agenda:</u> Motion made by Loren Lippincott and seconded by Steve Benton to approve the agenda. Motion carried.

<u>Approval of Minutes:</u> Motion made by Dan Davis and seconded by Jay Gasser to approve the minutes from May 17, 2011. Motion carried.

Committee Reports:

<u>Plan of Review</u> – Seven plans were reviewed. One plan needed minor revisions. Motion was made to approve all seven plans by Loren Lippincott and seconded by David Innis. Motion carried.

Community Right-to-know – Ron Sagen stated he had nothing to report.

♦ Membership – Jay Gasser made a motion that LEPC members listed on the LEPC Election Ballot be voted in for another 3-year term. This was seconded by Ron Sagen. Motion carried.

Jay made a motion that Major Bob Fay, Salvation Army, Janesville, be recommended as a new member replacing David Diestler whose term will expire July 31st. This was seconded by Loren Lippincott. Motion carried.

Jay stated he had received a copy of a letter from Jerry Schuetz, formerly Chief of Police, City of Milton, recommending Lieutenant John Conger as his replacement, to fulfill the balance of his term which expires July 31, 2013. Motion was made by Jay and seconded by Loren Lippincott to recommend John Conger as Jerry Schuetz's replacement. Motion carried.

Emergency Management Report:

It was explained that this item was for the County Health Department which serves as contractor and prepares the EPCRA facility and farm plans.

Spill Report – Shirley Connors

Tier Reporting – Shirley Connors

Shirley advised the Committee there were just two facilities who had not send in their Tier II information.

<u>Training</u> - Shirley Connors

Blackhawk Technical College is offering several NIMS training classes sponsored by Texas A&M University. August 22nd, there is a MGT 347 ICS Forms training class scheduled. She also advised that MGT 313 training class, which is equivalent to NIMS 300 training, is scheduled for August 23 and August 24. Texas A&M University is requiring all participants to take a 4-hour study course on line before the MGT 313 training course.

Ron Sagen advised that some participants from City of Janesville Fire Department will participate in a HazMat Basic Chemistry with Field Identification Laboratory on July 26, 2011. He further explained that there is a new kit that allows identification of unknown substances and tell if hazards are present as well as other information.

Shirley stated that all of the equipment has been received for the Hazmat Grant and invoices will be sent to Wisconsin Emergency Management in Madison.
