**RESCINDING RESOLUTION 10-5A-039 AND RE-ESTABLISHING
THE SALARY FOR ROCK COUNTY SHERIFF FOR THE 2011-2014 TERM**

1 WHEREAS, on May 13, 2010, the County Board Established rates for the Sheriff's position for the 2011-2014
2 term with a 0% increase in 2011, 0% increase in 2012, 1% in 2013 and 1% in 2014; and

4 WHEREAS, the County Board Staff Committee has determined that the Sheriff's salary is currently behind the
5 Chief Deputy position and substantially behind both the police chief for the City of Janesville and the police
6 chief for the City of Beloit; and

8 WHEREAS, if the current salary structure remains in place, the Sheriff will be even further behind in the
9 future; and

11 WHEREAS, the County Board Staff Committee believes that the County Board should rescind the previous
12 action and adjust the salaries appropriately.

14 NOW THEREFORE, BE IT RESOLVED, by the Rock County Board of Supervisors in session this 27th day of
15 May, 2010, that they rescind Resolution 10-5A-039 and furthermore that they set the increase in salary for the
16 Rock County Sheriff as per the below schedule: 0% effective January 1, 2011, a one-time lump sum payment of
17 \$5,000 added to the base effective January 1, 2012, 2%, effective January 1, 2013, and 2%, effective January 1,
18 2014 to be paid over a period of 26 regular pay periods throughout each year.
