Authorizing the Sheriff's Office Purchase of Ten Portable Radios

WHEREAS, the 2022 budget request includes the purchase of ten portable radios; and,

WHEREAS, the Sheriff's Office will purchase the radios as spares to be used when existing radios need repair, issued to new hires, or during special events; and,

WHEREAS, section 2.218 (4) of the Purchasing Ordinance does allow Rock County to purchase equipment through a cooperative purchasing agreement with the State of Wisconsin under Contract #505ENT-O22-SAFETYCOMM-05; and,

WHEREAS, all of the radios purchased during the Portable Radio Replacement project included in the 2021 budget, have been assigned to existing staff, and;

WHEREAS, General Communications, in Madison, Wisconsin maintains the Sheriff's Office radio and communication systems, and;

WHEREAS, the Sheriff's Office and the Purchasing staff have reviewed the quote and recommend purchasing ten L3Harris XL-200P Portable Radios.

NOW, THEREFORE BE IT RESOLVED by the Rock County Board of Supervisors assembled this 10th day of February 2022, that a Purchase Order be issued, to General Communications, Madison, Wisconsin, totaling the amount of \$50,664.10 for the purchase of ten of the 2022 budgeted Sheriff's Office Portable Radios.

EXECUTIVE SUMMARY

Authorizing the Sheriff's Office Purchase of Ten Portable Radios

The Sheriff's Office 2022 approved budget contains the purchase request of ten Portable Radios for the Sheriff's Office.

The initial Portable Radio Replacement project was completed in budget year 2021. The new radios have proven to be a better fit for the needs of the Sheriff's Office, and have improved officer safety. When the Sheriff's Office purchased last years' budgeted radios, they purchased only as many radios as were needed for their existing staff. The purchase of ten additional radios will facilitate the need for a spare, when a radio needs to be sent in for repair, needs to be issued to a new hire, or during an event where we have several municipalities in need of communicating.

General Communications, in Madison, Wisconsin, maintains the Sheriff's Office radio and communication systems. The Sheriff's Office and the Purchasing staff reviewed the quote, and recommend purchasing the L3Harris XL-200P Portable Radios from General Communications of Madison, Wisconsin in the amount of \$50,664.10. This purchase is listed under the Sheriff's Office 2022 budget line 21-2100-0000-67120 Capital Assets \$2,000- \$25,000.
