Awarding Contract for the Purchase of Two Kubota Utility Vehicles

WHEREAS, the new Dr. Daniel Hale Williams building will be needing one for sidewalk snow removal; and,

WHEREAS, the ford tractor at the Jail that is used for sidewalk snow removal is requiring many costly repairs annually; and,

WHEREAS, the Jail utility vehicle will be used at the Jail, 911 Communications Center as well as Youth Services Center; and,

WHEREAS, funds were budgeted in 2022 for these two utility vehicles and,

WHEREAS, the Kubota utility vehicles are available through the Sourcewell cooperative buying group contract pricing, Contract # SRTV-X1100CWL_HS

NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this 13th day of January, 2022 does hereby approve and authorize awarding a contract in the amount of \$55,000 to Johnson Tractor in Janesville WI, for the purchase of two Kubota Utility Vehicles.
