- 17 attached report in the amount of \$1,710,993.04, are hereby ratified.

- 20 hereby adopted and that the resulting tax levy for 2010 be in the amount of \$ 58,932,568 which
- 21 reflects a rate of \$ 6.105960 per \$1,000 of equalized valuation.
