- 1 **WHEREAS**, Section 2.218(3)(c) of the Purchasing Ordinance does allow Rock County to purchase
- 2 vehicles through a cooperative purchasing agreement with the State of Wisconsin under contract #15-
- 3 07006-202; and,

- 5 **WHEREAS**, Ewald Automotive of Oconomowoc, Wisconsin was awarded the 2013 State Contract for
- 6 4-Door Sedans; and,

- 8 **WHEREAS**, the staff of Public Works did review the State of Wisconsin bid specifications and
- 9 recommends purchasing five 2013 Chevrolet Impala LT Sedans through the State bid. These sedans will
- 10 replace existing vehicles that are scheduled to go to auction.

- 12 **NOW, THEREFORE, BE IT RESOLVED**, by the Rock County Board of Supervisors duly assembled
- 13 this 26 day of September, 2013, to authorize the purchase of five 2013 Chevrolet
- 14 Impala LT Sedans through the State Contract from Ewald Automotive of Oconomowoc, Wisconsin in the
- 15 amount of \$95,380 (\$19,076 each).


