**Committee Reports**

**Membership-** Jay Gasser introduced Loren Cox who is interested in a vacant media position. Nomination made by Sgt. Shena Kohler reported that Deputy Chief Todd Kleisner will be taking retired DC Terry Sheridan's position. **Emergency Management Reports**

**Current Events**

Sgt. Shena Kohler discussed current status of the Emergency Operations Center in navigating the COVID-19 pandemic and is transitioning into the vaccine phase of recovery. Emergency Management is gearing up for typical spring flooding events.

**Budget Report**

The budget report was unavailable at the time of the meeting.

**Spill Report:**

The spill report was provided. Questions were raised regarding follow-up/ cleanup information. Sgt. Shena Kohler stated EM gets the information from agencies or the DNR. Many times we did not receive any cleanup information, but can invite the DNR to a meeting to explain their process.

**Training:**

Sgt. Shena Kohler discussed virtual training options and many can be found listed at [trainingwisconsin.org](http://trainingwisconsin.org). She also discussed Rock County was chosen by the state to be a remote site for SIMCOM exercise, May 6, 2021, and to be the host site in winter 2022. SIMCOM is a radio/communications interoperability exercise. More information to come. Sgt. Kohler also discussed that if anyone is interested in bringing certain trainings to our county to let her know as she can request classes from the state.

**Public Health:**

Rick Wietersen introduced the new public health including the new Rock County Health Officer, Katrina Harwood, and also the new health educator, Michael Niles, who will be replacing Alison Chouinard's position in her emergency preparedness role. He also shared some COVID testing data and that it is trending downward. He shared that 26% of Rock County residents have received their first dose and 17% have gotten their second dose and are considered fully vaccinated.

Lieutenant Jason Daskam discussed team trainings they have been doing with Milton and Edgerton departments.

Jay Gasser, from Abitec, reports they are doing well.
