FAST (Families and Schools Together) presentation

- Training is provided to local teams to enable them to run the program within their communities.
- FAST covers preschool programs through high school.
- Programs run 8-10 weeks (10 weeks for middle school); typically two cycles are offered per year.

CST Grant update

- Jordyn Jenkins and Ellie Kone are joining the team as facilitators.
- Jamie Proctor is using a wrap-around approach to Family Team meetings.
- Grant funds can be used to provide supports and services for families as well as for staff trainings.

CCOP Update

- There has been an increase in the number of children being served through CLTS/CCOP.
- Families are getting established with Medicaid more quickly.
- Wait list times have been reduced to 4-6 weeks.

New Building Update

The Human Services Department has moved into its new facility at 1717 Center Ave., the Dr. Daniel Hale Williams Resource Center (DWRC). All Human Services programs are now being offered from this centralized location. Programs housed at the Eclipse Center will continue to serve the Beloit community.
