# Executive Summary Amending the Sheriff's 2018 Budget to Use Equitably Shared Funds for Small Unmanned Aircraft System

The Department of Justice Asset Forfeiture Program is a nationwide law enforcement initiative that removes the tools of crime from criminal organizations and deprives wrongdoers of the proceeds of their crimes. Federal law authorizes the Attorney General to share federally forfeited property with participating state and local law enforcement agencies.

Equitably shared funds are required to be used by law enforcement agencies for law enforcement purposes only. The intent of the transfer is to enhance law enforcement. It must increase, not supplant the recipient's appropriated operating budget.

For their participation in the program, the Sheriff's Office received funds in the amount of \$24,290. The Sheriff's Office plans to use the funds to purchase a small unmanned aircraft system (UAS) to help fulfill their public safety mission.

The Rock County Sheriff's Office is responsible for 726 square miles. The area is largely rural/farm land with several bodies of water, the cities of Janesville and Beloit, and several smaller municipalities. The Sheriff's Office will use the unmanned aircraft system to search for missing persons, to get aerial views for water rescues, and to take aerial photographs of major accident scenes, outdoor crime scenes, and natural disaster areas. The unmanned aircraft system will give the Sheriff's Office an efficient and effective way to conduct open field searches for outdoor marijuana grows.

Several Deputies have already attended training on unmanned aircraft system programs. The Sheriff's Office has developed policies and proceedures regarding the unmanned aircraft system program.

Per the Purchasing Ordinance, multiple quotations were solicited.

Amendment to Dane County Medical Examiner Intergovernmental

Agreement – Records Management

Rock County has contracted with the Dane County Medical Examiner's Office for medical examiner's services under an intergovernmental agreement since 2015 when the County transitioned from an elected coroner system to an appointed medical examiner system.

In the last year, the issue of open records requests has been a concern and recent changes to Rock and Dane Counties email systems has resulted in the need to define the keeper of records for records management purposes.

The current agreement stated that records of Rock County cases would reside with Rock County. The proposed amendment places the responsibility with the Dane County's Medical Examiner Office.

The proposed amendment is supported by Dane County and Rock County Information Technology and Corporation Counsel's Offices, along with the Medical Examiner's Department (Barry Irmen).

Given the relatively minor nature of the amendment, it is suggested by Rock County Corporation Counsel, that Committee action only is required.

# AMENDMENT TO THE INTERGOVENMENTAL AGREEMENT BETWEEN DANE COUNTY AND ROCK COUNTY FOR MEDICAL EXAMINER SERVICES

Now, therefore, Dane County and Rock County agree as follows:

#### A. Amendments to the Agreement:

7. **RECORDS.** Records for any action taken by the Medical Examiner's Officer on behalf of Rock County pursuant to this Agreement shall be considered Rock County records. The Chief Medical Examiner and the Dane County Director of Operations utilize the Dane County email system for purposes of all services provided to Rock County under this Agreement. The parties agree that any information maintained or contained in the Dane County email system related to a Rock County case or any services provided to Rock County under this Agreement shall be considered Rock County records, despite the fact that Dane County is the custodian of those emails.

Rock County shall be responsible for managing and responding to all public records requests and agrees to defend, hold harmless and indemnify Dane County, its officers, agents, boards, commissions, representatives, and employees from any and all losses, claims, liabilities, suits or actions of whatsoever nature resulting from or arising out of public records requests involving Rock County cases.

Dane County agrees to provide Rock County with any records in its possession in email format under this Agreement as soon as possible upon request. Dane County further agrees to retain any such records in its possession as an email for a period of at least seven (7) years, unless there is litigation pending regarding a particular matter, in which case said records will be maintained for as long as requested by Rock County.

Any other records generated as the result of an autopsy or any other action or service provided to Rock County under this Agreement shall be considered Rock County records, with Rock County as the records custodian. All such records shall be retained pursuant to Rock County's retention policy.

All other terms of this Agreement shall remain in full force and effect.
