LAND OWNER WAS PRESENT AND SHOWED ME ROUGHLY WHERE THE CORNER WAS. FD 3/4 PIN ABOUT 0.9' DEEP @ THE ERRONEOUS E 1/4 COR SEC 24 UNION TWP. FD 3/4 PIN ABOUT 8" ABOVE GRADE IN N/S FENCE LINE @ ERRONEOUS W 1/4 COR SEC 19. THE LAND OWNER STATED THAT HE PULLED THE ENTIRE CUT LIMESTONE WHICH HE THOUGHT WAS ABOUT 2" LONG AND AFTER REMOVING THE FENCE LINE WITH A DOZER, HE RESET IT AT THE LOCATION THAT HE THOUGHT IT WAS REMOVED FROM.

I DID NOT FIND A RECORD OF WHO SET THE PINS. THE FOLLOWING WEEK I USED THE PUBLIC WORKS TRACTOR TO EXCAVATE FOR THE STONE. THE FARMER WAS PRESENT. I DUG & FD A CUT LIMESTONE 3.2' LONG WITH TOP 1.0' BELOW GRADE IN FARM FIELD & ON LINE WITH N/S FENCE TO THE NORTH. I BROKE THE TOP 1.5' PORTION OFF. WITH THE TRACTOR I DUG ALONG THE ENTIRE WEST SIDE OF THE STONE. THE BREAK WAS CLEAN & EVEN. THE TOP IS NOW 2.5' BELOW GRADE. I PLACED 2 MAGNETS AT THE BASE AND 2 MAGNETS ON THE TOP. THE LS IS IN EXCELLENT CONDITION. THE TOP OF THE CUT LIMESTONE HAD ORANGE PAINT ON IT. I BROUGHT THE TOP BACK TO THE COURT HOUSE. THE FARMER SHOWED ME AND DESCRIBED THE OLD FENCE LINES & PREVIOUS GATE LOCATIONS. THIS APPEARS TO BE AS SHOWN IN BATTERMAN 1970 VOL 4 PG 449 RECORD. HE ALSO SAID HE REMOVED THE N/S FENCE LINE WITH A DOZER. HE STATED HE DID THE WORK AFTER 1970. CONSIDERING THE LENGTH, CONDITION, AND QUALITY OF THE STONE I BELIEVE THE FARMER DID NOT REMOVE IT AS STATED. THE POSITION IS VERY CLOSE TO THE LOCATION THAT RUGER'S DISTANCES AND VARANCES CALLED FOR.

C) Was the corner restored through acceptance of (1) an obliterated evidence location, or, (2) a found perpetuated location?

ACCEPTED THE CUT LIMESTONE. IT IS WITHIN 0.01' OF RUGER'S PRORATED DISTANCES AND WITHIN 0.4' OF A LINE BETWEEN THE SE & NE CORNERS OF SEC 24 UNION TWP. THIS IS IN HARMONY WITH LOCKE'S 1868 (VOL 1 PG 329 & #3607) RECORD WHERE HE DECLARED THE E 1/4 COR SEC 24 UNION TWP AS LOST. I DUG & FD NOTHING @ W 1/4 COR SEC 19. AT THE W 1/4 COR SEC 19 I PLACED A POLY/CARSONITE @ REG. DISTANCE & ON LINE WITH THE CUT LIMESTONES.

THE ONLY CALL FOR THE PINS IS BY LATHROP'S SURVEY #15421 IN 2006. ALTHOUGH HIS MAP STATES HE FOUND THEM, I BELIEVE HE SET THE PINS AND THE MAP LEGEND SYMOBLE IS IN ERROR. I BELIEVE THIS IS SUPPORTED BY THE FACT THAT HE CALLS FOR THE FD PIN @ E 1/16TH COR OF SE 1/4 SEC 24 TO BE MIDWAY AND ON LINE WITH THE E 1/4 & SE COR OF SEC 24. SUPPOSEDLY SUNNY SET A PIPE AT THIS LOCATION & THERE IS NO OTHER RECORD OF A MONUMENT AT THIS LOCATION SINCE THEN.

I TOLD RON COMBS & HE STATED HE WAS NOT CONCERNED BECAUSE THIS WOULD HAVE LITTLE EFFECT ON HIS SURVEY LINE.
