 1986 BARNES BY USING BLEEDHORN'S SUBDIVISION MAP DISTANCES THE CORNER IS COMPUTED TO BE 11.67' SOUTH OF THE SW CORNER OF LOT 16. IS IN HARMONY WITH THE SCALED LOCATION ON THE PLAT. ESTABLISHED THE CORNER AT THE RECORD DISTANCE FROM THE WEST LINE OF LOT 16 AND THE NW CORNER OF LOT 17. THESE NORTH SOUTH DISTANCES DO NOT AGREE WITH KERCH'S SHIELD'S SUB DISTANCES. THE CORNER AS PLACED IS IN HARMONY WITH RUGER'S 1870 DISTANCES TO THE SW CORNER OF SECTION 6 AND THE COMPUTED INTERSECTION OF THE QUARTER LINES AND EAST QUARTER CORNER OF SECTION 6. DID NOT EXCAVATE FOR THE CORNER BECAUSE OF UNDERGROUND IMPROVEMENTS. PLACED POLY. MONUMENT.
