CUT LIMESTONE WAS PROBABLY DESTROYED BY INSTALLATION OF CMP. THE LOCATION OF THE S 1/4 COR SEC 17 IS 1.29' OFF A LINE BETWEEN THE SW & SE CORNERS OF SEC 17 AND WITHIN 0.62' OF THE MID POINT.
