## Notice of Public Informational Meeting

WisDOT Project I.D. 5798-01-03  
CTH F, Rock County  
USH 14 – South Limits Edgerton

ALL INTERESTED PERSONS ARE HEREBY NOTIFIED that Rock County and Mead & Hunt, Inc., consulting engineers will host a Public Informational Meeting on **Thursday, May 4, 2017, from 5:00 p.m. to 7:00 p.m.**, at the Fulton Town Hall, located at 2738 West Fulton Center Drive, in Edgerton.

The purpose of this meeting is to present the final design, proposed right-of-way limits, anticipated construction schedule and to answer any questions you may have concerning the roadway rehabilitation project for CTH F. This meeting is the third and final scheduled informational meeting for this project. The previous two meetings were held on December 11, 2013 and April 7, 2016. Comments received from those meetings were considered and included in the current design.

The meeting will consist of an open-house format. You may attend anytime between 5:00 p.m. and 7:00 p.m. A short presentation will be provided at 5:30 p.m. by Rock County staff and the design consultant. Enclosed is a project location map that shows the public meeting location.

The project was broken up into three sections for construction purposes due to funding constraints. Currently only the urban section (section 2) through Indianford is funded for construction in 2018. Rock County is re-applying for funding for the remaining sections. No date has been determined as to when construction funding may become available for the remaining sections of CTH F.

Within the community of Indianford, the existing one-way couples will remain one-way streets. The street section will be converted from rural to an urban street section to include curb and gutter and storm sewer. Sidewalks are not proposed on the project with the exception of a short section of sidewalk on the approaches to the Rock River Bridge.

Minor impacts to resources protected by Section 4(f) of the U.S. Department of Transportation Act of 1966 may occur. The Section 4(f) properties include Indianford Park and the Indianford Dam and Powerhouse. Improvements to Indianford Park include repaving the parking lot and adding new sidewalk and storm sewer. The Indianford Dam and Powerhouse are listed on the National Register of Historic Places. ***This notice serves as notification of this project to persons with a concern for or knowledge of historic buildings or structures located along this project.*** Such persons are encouraged to attend this meeting or provide comments. The project activities and potential impacts to the section 4(f) resources will be discussed at this meeting.

The meeting location is wheelchair accessible. Citizens planning to attend the meeting who are deaf or hard of hearing and who require an interpreter may request one by contacting Mead & Hunt at least three working days prior to the meeting via the Wisconsin Telecommunications Relay System (dial 711).
