COMBS STATED THEIR RECORDS INDICATED THE CORNER THEY USED IN THE 1980 SURVEY WAS ABOUT 2.5' EAST OF THE ALUM. MON. THIS APPEARS TO BE IN HARMONY WITH THE 1997 LATHROP SURVEY STATEMENT. SINCE IN 1975 SCHROEDER DUG TO A DEPTH OF 4' & FOUND LEE'S 1881 STAKE & HARD HEAD STONES I ACCEPTED THAT LOCATION. ALSO THOM STATED IN HIS 1964 SURVEY, MAP #5654, THE 1/4 COR ACCORDING TO OCCUPATION. SINCE HE DID NOT FIND RECORD EVIDENCE AND SCHROEDER DID NOT FIND HIS PIN, I DID NOT ACCEPT THIS POSITION
