# THIRD ADDENDUM to LEASE AGREEMENT Between Southern Wisconsin Regional Airport County of Rock, Wisconsin and SC Aviation, Inc.

The County of Rock, Wisconsin, a municipal corporation, duly organized and existing under the laws of the State of Wisconsin, hereinafter referred to as LESSOR, and SC Aviation, Inc., entered into a certain contract hereinafter called LEASE dated the 24<sup>th</sup> day of August, 1999.

WHEREAS, the parties hereto hereby agree to modify the existing LEASE AGREEMENT as follows effective this \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2015:

The LESSEE wishes to add additional land to the LEASE AGREEMENT, which will now be shown as Exhibit B in the original LEASE AGREEMENT, for the purpose of erecting a building to expand their current business and wishes to amend the original LEASE AGREEMENT by modifying the following:

#### **ARTICLE 2 - TERMS**

#### 2.1 Term of Lease

The term of this Lease, subject to earlier termination as hereinafter provided, shall be for the period of twenty-five (25) years commencing on \_\_\_\_\_\_\_, 2015, through October 31, 2040. Between six months and one year prior to the expiration date of this Lease, LESSEE may request, in writing, that the LESSOR negotiate a new Lease with it. If timely notice is given to LESSOR, LESSOR shall meet with LESSEE in good faith to negotiate a new Lease.

#### **ARTICLE 3 - CONSIDERATION**

#### 3.1 Consideration

LESSEE agrees to pay to LESSOR, the sum of TEN THOUSAND SIX HUNDRED FIFTY-TWO DOLLARS AND EIGHTY-EIGHT CENTS (\$10,652.88) per year for the use of leased PREMISES, representing a rental charge of (.1119) cents per square foot for NINETY-FIVE THOUSAND TWO HUNDRED (95,200) square feet of unimproved land and the sum of TEN THOUSAND EIGHT HUNDRED NINETY-FIVE DOLLARS AND THIRTY-SIX CENTS (\$10,895.36) per year for the use of leased PREMISES, representing a rental charge of (.1792) cents per square foot for (60,800) square feet of improved land. During the month of December, the annual rental charge shall be adjusted with said rental charge to be comparable to land rentals being charged for other airport LESSEES leasing land for hangar buildings at Southern Wisconsin Regional Airport.

#### 3.2 Payment

As provided in Section 3.1, the rental charge shall begin upon receipt of occupancy permit. Payments in the amount of <u>ONE THOUSAND SEVEN HUNDRED NINETY-FIVE DOALLARS AND SIXTY-NINE CENTS (\$1,795.69)</u> representing a total of <u>TWENTY-ONE THOUSAND FIVEHUNDRED FJORTY-EIGHT DOLLARS AND TWENTY-FOUR CENTS (\$21,548.24)</u> per year shall be paid on/or before the first of each month.

#### **ARTICLE 39 – NOTICE**

Any notice required to be given in this Lease by either party is to be by registered mail with return receipt or by personal service. Notice to LESSOR shall be sent, delivered to or served upon the Airport Director, Southern Wisconsin Regional Airport, 1716 W. Airport Rd. Suite 100, Janesville, Wisconsin 53546. Notice to LESSEE shall be sent, delivered to or served upon SC Aviation, Inc., 4120 South Discovery Drive, Janesville, Wisconsin 53546 with a copy of any such notice to LESSEE being also required to be concurrently sent in the manner specified in the LEASE to Jeffrey R. Surlas, Esq., Colony Brands, Inc., 1112 7th Avenue, Monroe, Wisconsin 53566. Either party may designate a different address by delivering, sending or serving written notice of such change of address upon the other party.

IT IS HEREBY ALSO AGREED that this Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument, provided that all such counterparts, in the aggregate, shall contain the signatures of all parties hereto. Copies of this Agreement, as executed by any party hereto and delivered by facsimile or e-mail to the other party hereto, shall be deemed to be original counterparts for all purposes.

Except as otherwise expressly set forth herein, the LEASE remains unmodified and in full force and effect.

# Executive Summary Amending Chapter Three of Ordinances Specific Speed Limits - CTH G

On October 23, 2014, the Rock County Board of Supervisors approved amendments to the speed limits on many county trunk highways. These amendments included speed zone changes on CTH G between the City of Beloit city limits and City of Janesville city limits. This amendment was consistent with the speed zones planned for the CTH G reconstruction project. The project design provided a 45 mile per hour (mph) speed zone beginning 0.61 miles (3,200 feet) south of WIS 11 continuing northerly to the intersection of CTH G and WIS 11.

With the recently approved Dollar General Drive access on CTH G, adjustments to the speed zone are necessary.

Based on the plan for the Dollar General Drive access intersection, an extension of the speed zone from 0.61 miles (3,200 feet) south of WIS 11, to a point 1.00 mile (5,280 feet) south of WIS 11 is recommended.
