Change Order for Rock County Courthouse Security System Upgrade and Replacement – Phase 1

"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors, duly assembled this _____ day of _____ 2018, approves a change order in the amount of \$34,000 for installing the parking structures cameras under Phase 1 of the security system upgrade and replacement at the Rock County Courthouse which was awarded to Gilbank Construction Inc. of Clinton, WI, in the amount of \$1,743,000; and,

BE IT FURTHER RESOLVED that a \$20,000 contingency also had been approved to cover any possible unforeseen items."

Supervisor Yeomans moved approval of the above resolution, second by Supervisor Homan.

Mr. Sutherland said this part of Phase 1 was separated out as the outcome of the parking structure was not known at that time.

Mr. Sutherland said there will be a change order coming as he had just found out about some additional needs, which will be on a future agenda.

ADOPTED.

Updates.

<u>UW Rock County Boiler Update</u> Mr. Sutherland went over the timeline of events of replacing the boiler at UW Rock County. He said that if the shipping company had not dropped the boiler, thus damaging it more, the amount would have been about half the cost of the \$35,500 replacement by just putting in a new heat exchange. Mr. Sutherland said the insurance company is still working with the shipper on this, and he is still gathering information, asking for logbooks, check lists, etc. from UW Rock County.

Supervisor Yeomans suggested putting a signoff sheet on each boiler to show dates they have been worked on.

Supervisor Yeomans asked where the funds came from to cover the costs. Mr. Sutherland said the costs came for the repair and maintenance account.

<u>Adjournment</u>. Supervisor Yeomans moved adjournment at 8:29 A.M., second by Supervisor Zajac. ADOPTED.
