<u>Call to Order</u>. Chair Brill called the meeting of the General Services Committee to order at 8:00 A.M., Tuesday, November 3, 2015 in Conference Room N-1, Rock County Courthouse East.

Awarding Contract for Security / Mass Notification Improvements at the UW-Rock County Campus

"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this day of, 2015, that a contract for the purchase and installation of the security/mass notification and fire alarm systems be awarded to Gilbank Construction of Clinton, WI, in the base bid amount of \$826,100.00, plus the alternate bid of \$239,000.00 for the fire alarm system; and
BE IT FURTHER RESOLVED, that a project contingency in the amount of \$105,000.00 be established to cover change orders approved by the General Services Committee, and miscellaneous project costs; and
BE IT FURTHER RESOLVED that the 2015 General Services Budget be amended as follows:

BE IT FURTHER RESOLVED , that payments be made to the vendor upon approval of the General Services Committee."
Supervisor Heidenreich moved approval of the above resolution, second by Supervisor Zajac.
Supervisor Nash said he is still waiting for a formal paper from Corporation Counsel on projects not completed in a timely manner. Mr. Kuglitsch said this is a contract and if they don't complete things in a timely manner we would contact them and work through the process before takin them to court.
Supervisor Heidenreich asked about having completion dates added to the contracts. Mr. Leu said each project is a little different and that he would not recommend having a completion date in the contract as they will have to work around the college's schedule.
Supervisor Nash said he is not looking for a hard completion date, he is looking for something on compliance.
Supervisor Heidenreich said there seems to be a lot of projects that are drug out, they are just looking for ways to get some of these projects completed in a more-timely manner, and a way to hold them accountable. Mr. Kuglitsch said there are almost always things that come up to cause delays. He added that they can put specific timelines in specific contracts. Mr. Leu added that sometimes there could be liquidated damages, and that the problems can be handled on a case by case basis. Ms. Millis said we would also need to look at the specs to see what or if we may have caused the delay. Mr. Leu added that we have already put the project four months behind.
Supervisor Heidenreich said he feels these things need to be better communicated to the Committee.
PASSED on the following vote: Yes – Supervisors Brill, Brien, Heidenreich and Zajac; No – Supervisor Nash.
Awarding Contract for Boiler/Stack Replacement at the Courthouse
"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this day of, 2015, that a contract

for boiler/stack replacement at the Courthouse be awarded to Butters Fetting of Janesville in the base bid amount of \$246,000.00; and

BE IT FURTHER RESOLVED, that a project contingency in the amount of \$15,000.00 be established to cover General Services Committee approved change orders, and project related costs; and

BE IT FURTHER RESOLVED that payments be made to the vendor upon approval of the General Services Committee."

Supervisor Heidenreich moved approval of the above resolution, second by Supervisor Brien. ADOPTED.

Request Approval to Replace Cabinet and Countertop at the Health Department.

Supervisor Zajac moved to approve the replacement of cabinets and countertops at the Health Department to Wynn O. Jones for a total of \$8,947, second by Supervisor Heidenreich. ADOPTED.

<u>Discussion and Possible Action on Request from WKOW-TV to Place a Camera on the Courthouse Roof.</u> Mr. Terronez said he met with representatives from WKOW and General Services and found a likely location would be in front of the Judges Conference Room. He said this will need to be discussed with the judges before any action will be taken.

<u>Discussion and Possible Action of Facilities Rooftop Policy.</u> Mr. Terronez said there is no action to be taken at this time.

<u>Tower Demolition</u> Mr. Leu said the contractor is working on submittals, permits and the safety plan.
