Fatal accidents reviewed

- 08/07/10 W. Hwy 59, E of N. Casey Road. Vehicle was traveling eastbound in westbound lane. A truck traveling westbound swerved into the eastbound lane to avoid vehicle at the same time the vehicle tried to return to eastbound lane. Driver was not wearing a seat belt. Alchohol was not a factor.
- 08/11/10 W. STH 81, E of S. Avon Store Road. Eastbound vehicle veered into westbound lane striking semi at 55 mph. Victim's alcohol level .24.
- 8/17/10 S. Garfield Ave. at E. Court Streed. Motorcycle failed to stop at stop sign striking SUV. No helmet. Victim's alcohol level .17.
- 8/18/10 Forest at Bittel. Scooter failed to yield right of way and was struck by oncoming vehicle. Uncontrolled intersection. No. Helmet. Victim's alcohol level .19.
- 8/20/10 South STH 140 at East STH 67. Motorcycle struck vehicle in intersection as it was proceeding from a stop. Speed a contributing factor. Victim's alcohol level .13. No Helmet.
- 8/21/10 Hwy 51/Main St., S. of Hwy 59, E of Fulton. Vehicle crossed lane of traffic, striking and entering building on NW corner, and striking another vehicle. Alcohol believed to be a factor.
