





B) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In advance of Hwy. 67 resurfacing, (Hwy. 140 – Walworth County line), I set control and surveyed existing monuments, (exposed), and witnesses throughout the project. At this location, I recovered the cast iron monument, and two, (2), witness monuments from a tie sheet, (V-17(1)), prepared by Don Barnes on May 10, 1994.

Post construction and witnessed per the sketch, I set a cotton gin spindle at the corner in the same location as the cast iron monument below.

C) Was the corner restored through acceptance of (1) an obliterated evidence location, or, (2) a found perpetuated location?

Restored through a found perpetuated location.

D) Describe any material discrepancy between the location of the corner as restored or reestablished and the location of that corner as previously restored or reestablished by distance and direction.
