


SHOW A PLAN VIEW DRAWING DEPICTING THE CORNER MONUMENT AND SURROUNDING PHYSICAL FEATURES, INCLUDING THE EXCAVATION AREA AND DEPTH. THE CORNER MONUMENT SHALL HAVE THE FOLLOWING CHARACTERISTICS: I) HAVE AT LEAST TWO PREDETERMINED BREAK-OFF POINTS; 2) IF BROKEN, LEAVE A PERMANENTLY MAGNETIZED REMNANT AT THE ORIGINAL POINT. 3) MUST BE EXTENDABLE. 4) THE CAP IS INSCRIBED. ROCK COUNTY SURVEY MONUMENT - PENALTY FOR DISTURBING MARKER. 5) OR AN EXISTING CUT LIMESTONE. AN IRON PIPE I 2 X 4'0" (MINIMUM) MAY BE USED IN AREAS WHERE GROUND WATER IS WITHIN ONE FOOT OF THE SURFACE. IF THE CORNER IS OCCUPIED BY AN IMPROVEMENT (MANHOLE, BURIED CABLE, ETC.) ANY DURABLE, DISTINCT MONUMENT MAY BE USED. CORNERS SHALL BE REFERENCED WITH AT LEAST 4 DURABLE WITNESS MONUMENTS. WITNESS MONUMENTS SHALL BE MADE OF CONCRETE, NATURAL STONE, IRON OR OTHER EQUALLY DURABLE MATERIAL, EXCEPT WOOD. DESCRIBE THE CORNER AND THE WITNESS MONUMENTS.

- (b.) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.
 - 4. 1867 S.D. LOCKE FOUND THE W.B.T. & STUMP OF E.B.T & OLD STAKE. HE PLACED A STAKE AND TOOK A B.T. W.O. 29N27E 59. HE ALSO PLACED A POST IN A MOUND AT THE 1/16th CORNER BETWEEN THE W 1/4 AND THE MW CORNERS OF SECTION 25.

I DUG AND FOUND NOTHING. IN 1967 R.H. BATTERMAN JR. FOUND A 13"X12"X11" H.H WITH PHE POINT UP AT THE 1/16th CORNER BETWEEN THE NN & W 1/4 CORNERS OF SECTION 25. THERE IS NO RECORD OF THIS STONE. IT IS WITH IN .5' OF BEING ON A STRAIGHT LINE BETWEEN THE NN AND SW CORNERS OF SECTION 25. I DETERMINED THE POSITION OF THE W 1/4 CORNER OF SECTION 25 BY PRORATING LOCK'S DISTANCES IN SECTION 25 And Section 26. THE PRORATED DISTANCES TO THE FENCE INTERSECTION IN SECTION 26 AND THE N/S QUARTER LINE OF SECTION 25 ARE IN HARMONY. THIS POSITION IS ALSO IN HARMONY WITH THE ROAD AND THE E/W FENCE. I USED THIS TO CONTROL THE EAST/WEST POSITION AND PRORATED THE DISTANCES TO THE NW AND SW CORNERS OF SECTION 25.


(c.) Was the corner restored through acceptance of (1) an obliterated evidence location, or, (2) a found perpetuated location?
