


ANY DURABLE, DISTINCT MONUMENT MAY BE USED. CORNERS SHALL BE REFERENCED WITH AT LEAST 4 DURABLE WITNESS MONUMENTS. WITNESS MONUMENTS SHALL BE MADE OF CONCRETE, NATURAL STONE, IRON OR OTHER EQUALLY DURABLE MATERIAL, EXCEPT WOOD. DESCRIBE THE CORNER AND THE WITNESS MONUMENTS.
