




SHOW A PLAN VIEW DRAWING DEPICTING THE CORNER MONUMENT AND SURFOUNDING PHYSICAL FEATURES, INCLUDING THE EXCAVATION AREA AND DEPTH. THE CORNER MONUMENT SHALL HAVE THE FOLLOWING CHARACTERISTICS: 1) HAVE AT LEAST TWO PREDETERMINED BREAK-OFF POINTS. 2) IF BROKEN, LEAVE A PERMANENTLY MAGNETIZED REMNANT AT THE ORIGINAL POINT. 3) MUST BE EXTENDABLE. 4) THE CAP IS INSCRIBED: ROCK COUNTY SURVEY MONUMENT - PENALTY FOR DISTURBING MARKER. 5) OR AN EXISTING CUT LIMESTONE. AN IRON PIPE 1 1/2 " x 4'0" (MINIMUM) MAY BE USED IN AREAS WHERE GHOUND WATER IS WITHIN ONE FOOT OF THE SURFACE. IF THE CORNER IS OCCUPIED BY AN IMPROVEMENT (MANHOLE, BURIED CABLE, ETC.) ANY DURABLE, DISTINCT MONUMENT MAY BE USED. CORNERS SHALL BE REFERENCED WITH AT LEAST 4 DURABLE WITNESS MONUMENTS. WITNESS MONUMENTS SHALL BE MADE OF CONCRETE, NATURAL STONE, IRON OR OTHER EQUALLY DURABLE MATERIAL, EXCEPT WOOD. DESCRIBE THE CORNER AND THE WITNESS MONUMENTS.

 - 1882 RUGER VOL 2 PG 410 PLACED LIMESTONE 18"X11"X4" & PUT LIMESTONE ON EAST AND SOUTH. HE DID NOT STATE WHAT HE FOUND OR HOW HE ESTABLISHED IT.
 - 1937 SUNNY VOL 3 PG 344 DUG 5'X5'X31/2' HOLE AND FOUND NOTHING

DUG AND FOUND NOTHING. LEE'S CORNER WAS NOT CLOSE TO THE MID POINT PER HIS MAP. I ESTABLISHED THE CORNER ON THE COUNTY LINE MIDWAY BETWEEN THE NW & SW CORNERS OF SECTION 31
