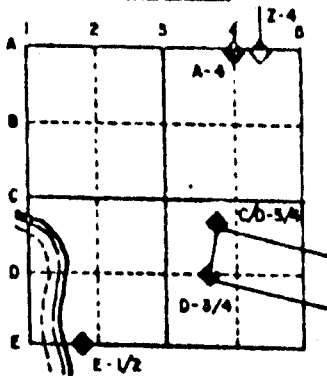

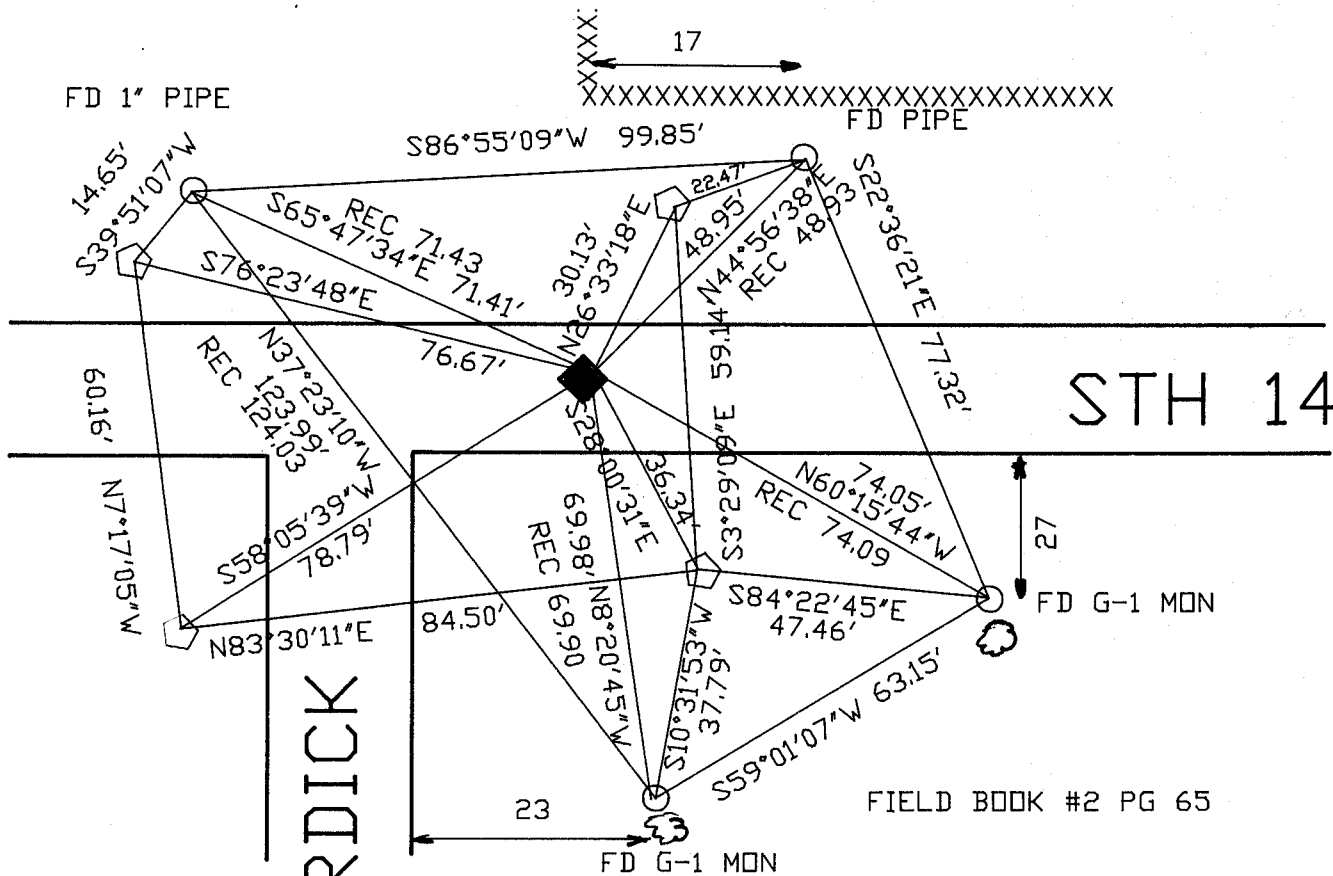

1986 BARNES J9 FOUND PK AT ROAD SURFACE. 2' DEEP FOUND PIPE. DROVE PIPE DEEP AND PLACED POLY MONUMENT ON TOP.

DOT PROJECT ENGINEER STATED THAT THE ROAD CONSTRUCTION CONTRACTOR MILLED THE SURFACE PRIOR TO DOT'S CREW REFERENCING THE CORNER. FOUND POLY MONUMENT WITH TOP MILLED OFF. REFERENCED SAME.

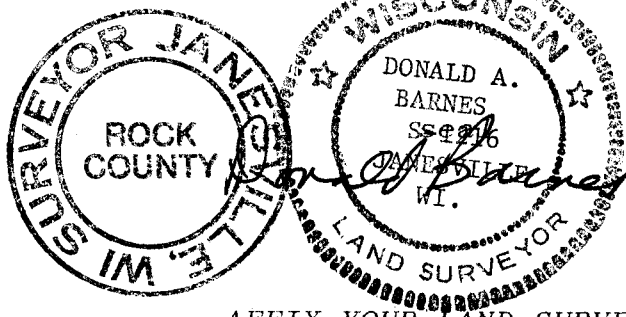
