COUNTY BOARD STAFF COMMITTEE Minutes – February 11, 2014

<u>Call to Order</u>. Chair Podzilni called the meeting of the County Board Staff Committee to order at 4:00 P.M. in Conference Room N-1 on the fifth floor of the Rock County Courthouse-East.

<u>Approval of Agenda</u>. Supervisor Arnold moved approval of the agenda as presented, second by Supervisor Bussie. ADOPTED.

<u>Discussion and Possible Action on Update to Administrative Policy 5.17 Health</u> Insurance. Mr. O'Connell said this just updates the policy to include domestic partner.

Supervisor Bussie said she thought the wording was already included in the policies when they voted on the resolution at the January 23rd County Board meeting.

Supervisor Jensen moved to update Administrative Policy 5.17 Health Insurance, second by Supervisor Arnold. ADOPTED on the following vote: YES – Supervisors Podzilni, Arnold, Bussie, Jensen, Kraft and Peer; NO – Supervisor Brill; Absent – Supervisors Mawhinney and Yankee.

<u>Discussion and Possible Action on Administrative Policy 3.04 Use of Portable Electric</u>
<u>Space Heaters.</u> Mr. O'Connell said in the older buildings the heat is inconsistent at times and some of the employees use electric space heaters. The Safety Committee has been discussing this for some time and has come up with this policy of fairly stringent guidelines each heater must comply with in order to be used.

Supervisor Brill said he feels inspections are very important and they will also help ensure pests are not brought in with the units.

Supervisor Peer moved approval of Administrative Policy 3.04 Use of Portable Electric Space Heaters, second by Supervisor Bussie. ADOPTED.

<u>Request for Vacation Carryover – County Administrator.</u> Mr. Knutson requested a carryover of 18 days, 6 hours of vacation.

Supervisor Brill moved approval for the County Administrator to carry over 18 days, 6 hours of vacation, second by Supervisor Bussie. ADOPTED.

<u>Discussion and Possible Action on Hiring Process for County Administrator.</u> Mr. O'Connell handed out and went over a tentative recruitment/hiring timeline for the upcoming County Administrator vacancy.

Supervisor Peer said no matter how careful we are in the hiring process a person can interview and seem like a good fit when, in fact, they are not. He said he would like to see a 1-year probation period to see if the person will work out. Mr. Knutson said the County Administrator serves at pleasure of the County Board, so this person is perpetually on probation. Mr. O'Connell said the new County Administrator will also have a contract and we will have a probationary period written into it.

Supervisor Jensen moved approval to accept the recruitment/hiring timeline, second by Supervisor Arnold. ADOPTED.

Executive Session: Supervisors Brill and Peer moved to go into Executive Session at 5:05 P.M. per Section 19.85(1)(e) Wis. Stats. Update on Collective Bargaining. ADOPTED on a roll call vote with the following: Ayes – Supervisors Arnold, Brill, Bussie, Jensen, Kraft, Peer, and Podzilni. Supervisors Mawhinney and Yankee were absent.

Chair Podzilni announced that the Committee would meet in closed session per Section 19.85(1)(e) Wis. Stats. Update on Collective Bargaining.

Supervisor Arnold moved to go out of Executive Session at 5:15 P.M., second by Supervisor Brill. ADOPTED.

<u>Adjournment</u>. Supervisor Arnold moved adjournment at 5:15 P.M., second by Supervisor Peer. ADOPTED.
