<u>Call to Order</u>. Chair Podzilni called the meeting of the County Board Staff Committee to order at 4:00 P.M. in Conference Room N1 on the fifth floor of the Rock County Courthouse-East.

<u>Approval of Agenda</u>. Supervisor Peer moved approval of the agenda as presented, second by Supervisor Thomas. ADOPTED.

<u>Citizen Participation, Communications and Announcements</u>. Mr. Phillips handed out a copy of the report, which was filled out by the person who borrowed his truck, and he went over the damage to the truck with the Committee.

<u>Approval of Minutes – August 9, 2016</u>. Supervisor Brill moved approval of the minutes of August 9, 2016, second by Supervisor Mawhinney. ADOPTED.

Authorizing the District Attorney to Increase a .4 Legal Stenographer Position to a 1.0 Legal Stenographer Position

Supervisor Kraft moved approval of the above resolution, second by Supervisor Peer. ADOPTED.

Recognizing September 21, 2016 as the International Day of Peace in Rock County, Wisconsin

"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors on this _____ day of _____, 2016, that the day of September 21, 2016 be recognized as International Day of Peace in Rock County.

BE IT FURTHER RESOLVED by the Board of Supervisors to call upon all Rock County citizens to support celebrating a day of global ceasefire and non-violence."

Supervisor Kraft moved approval of the above resolution, second by Supervisor Brill.

Supervisor Kraft moved to have the following on line 18 removed "as well as special events on September 21 and 23", second by Supervisor Podzilni. ADOPTED as amended.

Supervisor Mawhinney moved to have "Wisconsin" added after the word "Janesville" on line 18, second by Supervisor Bussie. ADOTPED as amended.

ADOPTED as amended.

<u>Discussion and Possible Action on Use of Rock County Logo.</u> Supervisor Brill moved to put this issue back on the table for discussion and possible action, second by Supervisor Sweeney.

Mr. Osborne reminded the Committee the discussion at the last meeting was regarding the use of the County Seal for the Get Connected program for United Way. He added that the Cities of Beloit and Janesville have already given United Way their approval to use their logos.

A handout of various ways the County Seal is used at this time was handed out. Mr. Smith went over the list with the Committee.

Ms. Millis added that some departments have table skirts and/or banners, which include the County Seal that are used when they set up a booth at various fairs.

Supervisor Bussie said she is in favor of having a clear policy on the use of the County Seal.

Supervisor Thomas asked if this request from United Way was a one-time use. Mr. Osborne replied that it is.

Supervisor Kraft moved approval of the one-time use of the County Seal for United Way and to setup parameters for the policy, second by Supervisor Bussie. PASSED on the following vote: YES – Supervisors Podzilni, Kraft, Peer, Bussie, Thomas, Sweeney and Mawhinney; NO – Supervisor Brill; Absent – Supervisor Arnold.

Discussion on the use of the County Seal on a banner for the NAMI conference.

Supervisor Sweeney moved approval on the one-time use of the County Seal on a banner for the NAMI conference, second by Supervisor Thomas. PASSED on the following vote: YES – Supervisors Podzilni, Kraft, Peer, Bussie, Thomas, Sweeney and Mawhinney; NO – Supervisor Brill; Absent – Supervisor Arnold.

Mr. Smith showed a couple examples of shirts with the County Seal on them and explained that Supervisor Fell had asked about having shirts made for the County Board Supervisors. The Committee discussed various ways the County Board Supervisors may want to use the County Seal and decided more discussion on setting parameters for the policy is needed on a future agenda again.

<u>Claim.</u> Ms. Timmerman went over the claim filed by Scott Phillips for damage to his car while traveling on Highway 14 during the seal coating project in the amount of \$9,402.33. She said Rock County was acting under the contract with the Wisconsin Department of Transportation and signage was in place 10 days prior to the start of work and warning signs were placed the day the work was done. She said the recommendation is to deny the claim.

Supervisor Sweeney moved to deny the claim, second by Supervisor Mawhinney. DENIED.

Executive Session: Supervisors Mawhinney and Sweeney moved to go into Executive Session at 4:45 P.M. per Section 19.85(1)(e), Wis. Stats. Regarding Negotiations on Pending Offer for Purchase of Public Property and per Section 19.85(1)(c), Wis. Stats. – Performance Evaluation – County Administrator. ADOPTED on a roll call vote with the following: Ayes – Supervisors Mawhinney, Sweeney, Thomas, Bussie, Brill, Peer, Kraft and Podzilini. Supervisor Arnold was absent.

Supervisor Bussie left after the first executive session.

Supervisor Sweeney moved to go out of Executive Session at 5:55 P.M., second by Supervisor Mawhinney. ADOPTED.

<u>Adjournment</u>. Supervisor Mawhinney moved adjournment at 5:55 P.M., second by Supervisor Peer. ADOPTED.
