Discussion and Possible Action on Policy 2.19 Community Agency Initiatives Policy (Donations Policy). Supervisor Peer moved approval of Policy 2.19, second by Supervisor Arnold. Mr. Smith went over the requested changes to V. and the title change for the section. He said he made the change to III.4. regarding the allocation being provided primarily with tax levy funding due to groups like Beloit Meals on Wheels.

Discussion on having a deadline in line with when the departments have to have

their budget requests in. Mr. Smith added the outside agencies would always be able to come before the County Board with a request, as they have always been able to do in the

past.

Supervisor Mawhinney moved to add the requests to be submitted at the same time departmental budgets are due to the County Administrator's Office, second by Supervisor Peer. ADOPTED.
