The 2019 1st quarter meeting of the Rock County Traffic Safety Commission was held on Wednesday, April 17, 2019 at the Rock County Sheriff's Office at 9:00AM.

Introductions

Introductions were made in roundtable fashion.

Approval of Minutes

Terry Sheridan motioned to approve the minutes of January 16, 2019. The motion was seconded by Hank Brill. Motion passed unanimously.

“Place of Last Drink” (POLD) Study – Rock County Prevention Network

Erin Menzel, Kelly Klingensmith and Megan Farrell of the Rock County Prevention Network provided a PowerPoint presentation on their “Place of Last Drink” study. Handouts of the presentation were distributed. The data used in the study was gathered from Rock County OWI arrests, March 2017-February 2018. The compiled data shows 71 establishments as a POLD, with 26 identified as POLD on 2 or more occasions.

Hank Brill requested the study be presented to the County Board. The Prevention Network agreed to the board presentation, but would want to increase the current data prior to scheduling.

Fatal Crash Review

- **January 23, 2019:** 2 vehicles/1 deceased – 20-year-old male. N USH 51 and N Kidder Rd. Video reviewed. Poor road conditions (snow and ice covered). ME: Negative toxicology
- **February 2, 2019:** 2 vehicles/1 deceased – 56-year-old male. STH 81 and Freeman Parkway. Video reviewed. Excessive speed. The crash is still under

investigation. ME: Toxicology .326 on decedent and positive for prescription drugs.

- **February 11, 2019:** 2 vehicles/1 deceased – 53-year-old male. CTH G and Sunny Lane. Video reviewed. Poor road conditions (snow, ice, slush). ME: Negative toxicology
