THE COMPUTATION INVOLVED DIVIDING GRID COORDINATES, AS DETERMINED BY DISTRICT 1 SURVEY AT 3 SECTION CORNERS (THE S 1/4 COR OF SEC 32, THE S.E. COR OF SEC 32 AND THE S 1/4 COR OF SEC 33, ALL IN T1N R14E) & BY THE ILLINOIS GROUND COORDINATES SHOWN AT THE SAME CORNERS ON ILLINOIS HIGHWAY PLAN R-92-022-90, AND THEN AVERAGING THE RESULTS.
