FD G-1 MONUMENT ON SOUTH SIDE OF STM 59 PARTIALLY IN GROUND. BENT ON NORTH SIDE OF ROAD. ONLY 1 TIE THAT WAS PLACED IN 1912 REMAINS. IT APPEARS TO HAVE BEEN DISTURBED. FOUND PK @ CENTER OF PAVEMENT THAT AGREED WITH DOT TIES. THE TIE AGREES WITH THE DISTANCE TO THE NW CORNER OF SEC 35. ELEVATION OF PAVEMENT IS 882.3 AND THE RECORD ELEVATION OF THE CAST IRON IS 881.7.
