

Commencing at the North end of a highway at or near the SW. corner of the N.W.¼ of Section 30 of the town of Rock, and the S.E. corner of the N.E.¼ of Section 25 of the town of Plymouth; thence running North upon the line between said towns about 1 mile to the ¼ post of Section 24, of the town of Plymouth and of Section 19 of the town of Rock; thence at an angle of 20° to a point 2 rods East of the line between said towns, thence North upon said 2 rods East of parallel with said town line about 15 rods; thence west at an angle of 20 degrees to the town line between said towns, thence North upon the town line between said towns to the N.E. Corner of Section 24 of the town of Plymouth and the N.W. corner of Section 19 of the town of Rock to intersect a highway in the town of Rock running east from said point of termination, the same being an accurate survey thereof caused by us to be made and said highway being upon the town line between said towns or as near to as the situation of the ground will admit, the line of said survey is the center of said highway and the same is laid out of the width of four rods.

We do further order and determine that the following described part of said highway, to wit; each of said towns of Rock and Plymouth shall bear an equal share in the expense of making and keeping in repair said highway, under the supervision of the supervisors of each of said towns, and that the damages awarded to and agreed upon with the owners of the following described lands, to wit:

The Chicago & Northwestern Rail Road The N. 5/8 N.½ N.E.¼ Sec. 24 of the town of Plymouth and the N.3/4 N.W.¼ N.W. ¼ Section 19 of the town of Rock excepting ten dollars shall be paid by said town of Plymouth, and the damages awarded to or agreed upon with the owners of the following described lands to wit: Ten Dollars of the N.5/8 N.½ N.E.¼ Sec. 24 of the town of Plymouth & N.3/4 N.W.¼ N.W.¼ Section 19 of the town of Rock S.¼ N.W.¼ N.W.¼ Sec. 19 of the town of Rock S.¼ N.W.¼ Sec.19 of the town of Rock N.W.¼, S.E.¼ Sec. 19 of the town of Rock S.w.¼S.E.¼ Sec.19 of the town of Rock, W½ N.W.¼ Sec. 30 town of Rock E.½ N.E.¼ Sec. 25 Town of Plymouth, S.E.¼ S.E.¼ Sec. 24 Town of Plymouth, N.E.¼ S.E.¼ Sec. 24 Town of Plymouth S.E.¼ N.E.¼ Sec. 24 Town of Plymouth, S 3/8. M½. M/E¼ Sec. 24 town of Plymouth shall be paid by the said town of Rock.
