


SHOW A PLAN VIEW DRAWING DEPICTING THE CORNER MONUMENT AND SURROUNDING PHYSICAL FEATURES, INCLUDING THE EXCAVATION AREA AND DEPTH. THE CORNER MONUMENT SHALL HAVE THE FOLLOWING CHARACTERISTICS: 1) HAVE AT LEAST TWO PREDETERMINED BREAK-OFF REMNANT AT THE ORIGINAL POINT. 3) MUST BE EXTENDABLE. IS INSCRIBED : ROCK COUNTY SURVEY MONUMENT - PENALTY FOR DISTURBING MARKER. 5) OR AN EXISTING CUT LIMESTONE. AN IRON PIPE 1 2 " 1 4'0" (MINIMUM) MAY BE USED IN AREAS WHERE GROUND WATER IS WITHIN ONE FOOT OF THE SURFACE. IF THE CORNER IS OCCUPIED BY AN IMPROVEMENT (MANHOLE, BURIED CABLE, ETC.) ANY DURABLE, DISTINCT MONUMENT MAY BE USED. CORNERS SHALL BE REFERENCED WITH AT LEAST 4 DURABLE WITNESS MONUMENTS. WITNESS MONUMENTS SHALL BE MADE OF CONCRETE, NATURAL STONE, IRON OR OTHER EQUALLY DURABLE MATERIAL, EXCEPT WOOD. DESCRIBE THE CORNER AND THE WITNESS MONUMENTS. CORNER CODE:

PAGE 37B SHOWS THE SW CORNER OF SECTION 25 AND STATES THAT
THE SOUTH 1/16TH CORNER OF THAT SW 1/4 IS A TRIANGULAR
POINTED LIMESTONE 15X14X12. HE DOES NOT STATE THE DISTANCE
TO THE SECTION CORNERS. HE SHOWS THE SECTION LINE AND
NORTH/SOUTH DISTANCES TO VARIOUS POINTS ON THE MAP.



 STATES THAT THE POINT OF BEGINNING IS S1-15W 340.56 FROM THE
 SECTION CORNER. THE BEARING AND DISTANCE TO A COMPUTED
 POSITION IS S1-40-00W 339.35. HE ALSO STATES THE DISTANCE
 AND BEARING FROM A LOT CORNER ON THE SOUTH SIDE OF LAWTON
 FROM A STONE MONUMENT AT THE INTERSECTION OF LAWTON AVENUE
 AND THE NORTH LINE OF SECTION 36 IS S52-23W 196.35. THE
 DISTANCE FROM A FOUND PIPE TO THIS COMPUTED POSITION IS S5655-38W 197.48.

 HIS MAP WHICH WAS FILED IN THE BELOIT CITY ENGINEER'S
 OFFICE SHOWS THE SOUTH LINE OF THE SW 1/4 OF SECTION 25.
 HE SHOWS NORTH/SOUTH DISTANCES FROM THE SECTION LINE TO
 VARIOUS MONUMENTS. HIS MAP CALLS FOR A DISTANCE OF 2641.82
 FROM THE EAST QUARTER CORNER TO THE SOUTHWEST CORNER OF
 SECTION 26. HE ALSO CALLS FOR AN ANGLE OF 90-12-30 AT THE
 SOUTHWEST CORNER OF THE SECTION. I COMPUTED AN ANGLE OF 9014-39. HIS MAP ALSO SHOWS THAT THE CORNER IS IN A
 BUILDING. THE COMPUTED DISTANCE FROM THE WEST QUARTER
 CORNER TO THE NW CORNER OF SECTION 25 IS 2631.29. BATTERMAN
 CALLS FOR A DISTANCE OF 2631.85. THE ANGLE NW CORNER-W 1/4
 CORNER-SW CORNER OF SECTION 25 IS 179-59-54. THIS ANGLE IS
 TO THE RIGHT.

I COULD NOT FIND ANY OTHER SUBDIVISION PLATS, PLAT OF SURVEYS, OR COUNTY SURVEYOR MAPS THAT CONTAINED THE SOUTH WEST CORNER OF SECTION 25. I PLACED THE CORNER IN THE POSITION THAT WAS MOST IN HARMONY WITH BATTERMAN'S SURVEY WHICH IS ALSO IN HARMONY WITH HOLMES AND RUGER'S SURVEYS. THESE VARIOUS CALL DISTANCES ARE SHOW ON THE ENCLOSED MAP. I DID NOT PLACE A MONUMENT BECAUSE THE CORNER IS INSIDE THE BUILDING.
