**ROCK COUNTY PARK AND CONSERVATION DIVISION**  
**REQUIREMENTS AND RESTRICTIONS FOR FERMENTED MALT BEVERAGE**  
**PERMIT**

- I. These permits shall only be issued to civic groups for specific events.
- II. Only licensed bartenders shall be used.
- III. All Wisconsin Statutes in relation to the dispensing and consumption of fermented malt beverages shall be strictly enforced.
- IV. A. A uniformed law enforcement officer will be at the specified sales area to conduct any checking of identification to determine age as may be necessary, and will be continually present during operation of the beer sales area.  
  
B. Permittee shall provide for checking and enforcement personnel to insure all these requirements are met.
- V. The Permit shall be valid for a single specified event and can be revoked with no notice if rules and requirements are not met.
- VI. No "carry-in alcoholic beverages" are permitted, only fermented malt beverages sold on site may be possessed or consumed on site.
- VII. Permittee shall furnish a "Certificate of Insurance" naming Rock County as an additional insured. This certificate must be in Rock County's possession prior to the grounds being set up for the event.

An excerpt from Chapter 11 of the Rock County Ordinances, 5.02(16)(a)(b) Intoxicants Prohibited:

"No person shall consume or possess any fermented malt beverage or intoxicating liquor, as defined by 1987 Wisconsin Statutes, sec. 125.02, on any property owned by Rock County, except that portion of the county airport designated by the Public Works Committee. Such possession and consumption of fermented malt beverages on the airport premises shall be subject to all applicable State Statutes and local ordinances including licensing of the restaurant operation by the appropriate municipal authority. The consumption of fermented malt beverages and wine, in all parks, except the 4-H County Fair Grounds, is allowed under a temporary permit issued by the Public Works Committee. The consumption of fermented malt beverages and wine on the 4-H County Fair Grounds is allowed under a temporary permit issued by the Agriculture and Extension Education Committee. Such temporary permits shall be subject to local licensing requirements and such other restrictions as the respective Committees may deem to be in the public interest. The Public Works and Agriculture and Extension Education committees may establish fees for the issuance of the permits referred to in sub (a) above to help defray the costs of park clean up.

**PERMIT**

TURTLE COMMUNITY ORGANIZATION is hereby authorized to dispense fermented malt beverages at Sweet-Allyn County Park from Friday, June 27, 2014 through Sunday, June 29, 2014 subject to licensing and state and local laws. This Permit is issued by the Rock County Public Works Committee under authority granted in Chapter 5, Subchapter 02, of the Rock County Ordinances.

### **PARTNERS FOR FISH AND WILDLIFE PROGRAM LANDOWNER AGREEMENT**

This Landowner Agreement (Agreement), dated 01/31/2014, between Rock County Parks and the U.S. Fish and Wildlife Service (USFWS) is entered into pursuant to authority contained in the Partners for Fish and Wildlife Act (P.L. 109-294), the Fish and Wildlife Coordination Act (16 U.S.C. 661 et seq.) and the Fish and Wildlife Act of 1956 (16 U.S.C. 742a-j), as amended. This project was selected for funding because the Landowner(s) share(s) a common objective with the USFWS to restore habitat for the benefit of Federal trust species on private lands, and the project supports priority actions identified in the Regional Partners for Fish and Wildlife (Partners) Program Strategic Plan.

Rock County Parks 3715 Newville Rd. Janesville, WI 53545, hereby agrees to participate with the USFWS in conducting certain wildlife management practices on lands owned or managed in Rock County, State of Wisconsin, described as follows: all of, or within, T4N R11E Sec 27, (see attached map in Exhibit A. for details).

In signing this Agreement, the Landowner(s) join(s) as a participant in a wildlife habitat improvement program and grants to the USFWS and any other cooperators signing this Agreement] authority to complete the habitat improvement project or the Landowner(s) may personally carry out management activities with financial or material support as described in attached Exhibit A. Any donation of supplies or equipment to the Landowner for carrying out the habitat improvements is included in Exhibit A. The activities conducted pursuant to this Agreement are not to replace, supplement or otherwise contribute to any mitigation or compensation that may be required of the Landowner(s) or other parties as a result of any mandated requirements.

The term of this Agreement (also referred to as the habitat retention period) will be completed on 01/31/2024. This Agreement may be modified at any time by mutual written consent of the parties. It may be terminated by either party upon 30 days advance written notice to the other party. However, if the Landowner(s) terminate(s) the Agreement before its expiration, or if the Landowner(s) should materially default on these commitments, then the Landowner(s) agree(s) to reimburse the USFWS prior to final termination for the prorated costs of all habitat improvements placed on the land through this Agreement. For these purposes, the total cost of the habitat improvements to the United States is agreed to be \$ 2,400.00

**Landowner:**

The Landowner(s) or his/her land manager, with legal authority over land management decisions, guarantee(s) ownership of the above-described land and warrants that there are no outstanding rights that interfere with this Landowner Agreement.

The Landowner(s) will notify the USFWS of planned or pending changes in ownership. A change of ownership shall not change the terms of this Agreement. The Agreement and terms shall be in effect on the described land for the term of the Agreement.

The Landowner(s) agree(s) to allow access (with advance notice) to the USFWS to implement the project described in Exhibit A, and to monitor project success.

The Landowner(s) retain(s) all rights to control trespass and retains all responsibility for taxes, assessments, and damage claims.

During the habitat retention period, the landowner must maintain the habitat restored under this award.

At the end of the habitat retention period, the habitat improvement project will become the sole property and complete responsibility of the Landowner(s). There shall be no obligation to the USFWS after the term of the Agreement has expired.

The Landowner(s) will be responsible for securing any necessary permits. Technical advice and support will be provided by participating agencies in the application for the permit(s). The Landowner(s) agree(s) to identify USFWS contribution to the project during public presentations, reports, or other information published about the project, as appropriate.

**USFWS:**

The USFWS will work with the Landowner(s) throughout the entire Agreement term to support actions needed to ensure that the project is designed and constructed per the Agreement and functions as intended.

The USFWS, its agents, or assignees will provide advanced notice prior to accessing the Landowner(s) property to implement the project described in the work plan, and to monitor project success.

The USFWS assumes no liability for damage or injury other than that caused by its own negligence, on the above acreage. The USFWS does not assume jurisdiction over the premises by this Agreement.

**Spatial Information Sharing:** In accordance with the Privacy Act of 1974, permission must be obtained from the Landowner before any personal information can be released. The only information that can be shared is payment information that is authorized by law. Therefore, Landowner consent is requested to allow for sharing of spatial information about this project solely with conservation cooperators providing technical or financial assistance with the restoration, enhancement or management of fish and wildlife habitat.

### **Description of Habitat Improvement Project and Objectives:**

Project consists of forestry mowing 6 acres of degraded oak savanna adjacent to Gibbs Lake in Gibbs Lake County Parks. Migratory bird nesting and foraging habitat will be enhanced. A hiking trail traverses through the restoration area affording the public opportunity to experience restored oak savanna.

### **USFWS will:**

The USFWS is going to plan, develop, and cost share the forestry mowing.

USFWS will continue to monitor and provide management recommendations to the landowner.

### **The Landowner(s) will:**

Provide an operator for the rented forestry mower.

Follow up the mowing with selective herbicide treatment of invasive tree and shrub resprouts.

Maintain and enhance the site with periodic grazing, mowing, or prescribed fire.

**Issue** – Renewal of House Rental Agreement Brandon Willard

**Discussion** –

Attached for your review are copies of the original lease that was approved on October 31<sup>st</sup>, 2011, and a letter from Brandon Willard requesting a one year extension. This letter was not received in time to place on the January 9, 2014 meeting when airport items were discussed. The Willard family has lived in the house for over two years and has been acceptable tenants during that time.

The current rental agreement on the airport house expired on January 31<sup>st</sup>, 2014.

Paragraph 2.2 states:

**2 - Terms**

(2.2) LESSEES may by written notice, 30 days prior to the end of the initial lease term and any subsequent one (1) year term, extend this Lease for another one (1) year term subject to the adjustment required by Paragraph 3.3, and with Public Works Committee approval.

**Recommendation** – That the Committee approve a one-year extension.

# Southern Wisconsin Regional Airport

## House Rental Agreement

This House Rental Agreement (hereinafter "Lease Agreement"), is made this 1st day of November, 2011, by and between the County of Rock, State of Wisconsin (hereinafter "LESSOR"), and Brandon Willard (hereinafter "LESSEES");

WHEREAS, LESSOR is the owner of certain real estate in Rock County, Wisconsin, known as the Southern Wisconsin Regional Airport (hereinafter "The Airport"), which includes certain buildings and certain other facilities used in connection with its operation of The Airport;

WHEREAS, LESSOR desires to Lease certain parts of The Airport to LESSEES, to grant LESSEES the right to use The Airport in common with others, and to grant to LESSEES the other rights herein set forth, upon the terms and conditions herein stated; and

In consideration of the terms, conditions, promises, and obligations herein set forth;

IT IS HEREBY AGREED, by and between LESSOR and LESSEES,  
That:

### 1 - Premises

LESSOR does hereby lease, demise, and let to LESSEES a dwelling at 3728 South Oakhill Avenue, located on the north side of The Airport.

### 2 - Terms

(2.1) The initial term of this lease shall be month to month from the date of signing until January 31<sup>st</sup> of the following year.

(2.2) LESSEES may by written notice, 30 days prior to the end of the initial lease term and any subsequent one (1) year term, extend this Lease for another one (1) year term subject to the adjustment required by Paragraph 3.3, and with Public Works Committee approval.

(2.3) Subsequent terms of this lease shall be for one (1) year commencing on the 1<sup>st</sup> day of February and ending on the 31<sup>st</sup> day of January. If the Lease is terminated or canceled, as provided in Paragraph 11, the term of this Lease shall be defined to end accordingly.

### 3 - Consideration

(3.1) LESSEES agree to pay to LESSOR for the use of leased premises the sum of Eight Thousand Six Hundred Forty and 00/100th's (\$8,640.00) dollars per year (2011 rates).

(3.2) One Twelfth (1/12) of the annual rent shall be payable on or before the 1st of each month, representing a monthly sum of Seven Hundred Twenty and 00/100th's (\$720.00) dollars. Late rental payments shall be subject to interest, thereon payable at the rate of one and one half (1 1/2) percent per month, until paid in full.

(3.3) It is further agreed that annually during each month of December, the fixed rental rates shall be re-negotiated and be effective February 1. Fixed rental rate will be based on the urban rate of inflation (CPI-U) and may not exceed four (4) percent of the adjusted rental rate of the preceding year. Rates will be rounded to the nearest whole dollar. The Airport Director shall be responsible for negotiating the yearly rental, subject to final approval by the Airport Public Works Committee.

(3.4) LESSEE shall pay a security and cleaning deposit an amount equal to one months rent. The security deposit includes a \$30.00 deposit for the two keys issued at the time of the signing of this agreement. Upon termination of this Lease said deposit will be returned by mail in the form of a check after a final inspection of the premises has been made, the premises are found to be in satisfactory condition as determined by the Airport Director, and both keys are returned. If only one key is returned to the Airport Director's office, the full \$30.00 key deposit will be forfeited.

#### 4 - Use

LESSEES agree to keep the premises in good repair and clean at his/her own expense, reasonable wear and tear excepted. LESSEES specifically agree to remove all trash and garbage in a safe and sanitary manner for the premises on a regular basis. Trash pick-up is normally on Friday. Trash and recyclables should be placed in appropriate containers and placed along-side Oakhill Avenue.

(4.1) It is agreed that decorating, redecorating, and remodeling or any other improvement to leased premises is the responsibility of LESSEES and that before any such improvement is to be performed, written consent of LESSOR must be first obtained.

(4.2) LESSEES shall be responsible for the cost of repairs due to misuse, neglect, or abuse to dwelling by LESSEES or visitors.

(4.3) It is agreed that LESSEES shall attach no personal property on the premises without the written consent of LESSOR. All personal property owned by LESSEES and attached to said premises pursuant to the written consent of LESSOR shall remain the personal property of LESSEES, provided that at such time as LESSEES may remove such property, the premises shall be restored to its original condition by LESSEES, unless waived by LESSOR.

(4.4) It is agreed that LESSEES shall not make, or permit to be made any disturbing noise which would interfere with the rights, comforts, or convenience of others, including but not limited to the playing of musical instruments or stereos.

#### 5 - Parking

LESSEES agree to use parking areas for personal and visitor use only, and not for storage of inoperable vehicles.

#### 6 - Appliances

The water heater and furnace are in satisfactory condition and are provided by and will be maintained by the LESSOR.

#### 7 - Access to Premises

LESSEES agree to and shall permit LESSOR, and the State of Wisconsin and United States Government to send their representatives and employees onto premises, for the purpose of an inspection thereof. In non-emergency situations, LESSEES shall be provided with reasonable advance notice of an inspection if LESSEES are available to receive such notice.

#### 8 - Sublease

This lease shall not be assignable nor any part of the premises subleased by LESSEES without the written consent of LESSOR.

#### 9 - Utilities

It is understood and agreed that LESSEES shall pay for all utility services used by LESSEES during the term of this Lease, which are incidental to the occupancy of said premises. LESSEES are specifically responsible for payment of telephone service, waste disposal, water and sewer charges, lights, gas, and any other services necessary.

#### 10 - Governmental Requirements

LESSEES agree to comply with the requirements of every applicable federal, state, and county law, rule and regulation, and with every lawful direction and order given by any public officer pursuant thereto.

#### 11 - Default by LESSEES

If default is made in payment of rent, at the times above stated, or if LESSEES shall break any of the agreements or provisions herein contained, or shall willfully or maliciously do injury to the premises, or shall file a petition in bankruptcy, or have any involuntary petition in bankruptcy filed against him/her, or make an assignment for the benefits of credits, the LESSOR or its legal representatives shall have the right at any time thereafter, without notice, to declare this Lease void and the terms herein ended and may re-enter the premises and expel LESSEES, using such force as necessary without prejudice to any remedies which LESSOR may have, to collect arrears of rent.

(11.1) LESSEES agree that at the termination of the within Lease, or any renewal thereof, he/she will quietly and promptly yield and surrender said premises to the LESSOR in as good condition of repair as when taken by LESSEES, reasonable wear and tear alone is expected.

#### 12 - Indemnity and Hold Harmless

LESSEES agree that the premises shall be used for the purposes set forth in the Lease and no other. LESSEES further agree to indemnify, hold harmless, and defend the County of Rock, its officers, agents, and employees from any and all liability including claims demands, losses, costs, damages and expenses of every kind and description, for bodily injury (including death)

and personal or property damage arising out of, or in connection with, or occurring during the term of this Lease where such liability is founded upon or grows out of the negligent or intentional acts or omissions of the LESSEES or LESSEES' officers, agents or employees.

(12.1) LESSEES agree that in order to protect itself and the County, LESSEES will at all times during the term of this Lease keep in force and effect renter's insurance and automobile liability insurance policies issued by a company or companies authorized to do business in Wisconsin. The County of Rock shall be named as an additional insured on said liability policies.

(12.2) Certificates of insurance acceptable to the County of Rock shall be filed with the County of Rock, Airport Director's Office, prior to the execution of this Lease. These certificates shall contain a provision that coverage afforded under these policies will not be canceled until at least fifteen (15) days prior written notice has been given to the County of Rock.

### 13 - Integration

This document is fully integrated embodying the entire agreement between the parties.

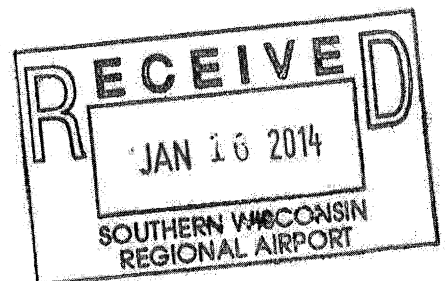

ISSUE - Approve Change of Access Use on Controlled Access Highway (CTH N) - Van Altena

DISCUSSION - Charles and Kathy Vogel own a parcel of land (Tax parcel # 6-13-76) on the south side of CTH N approximately 850 feet east of N. Vogel Road. They are selling it on land contract to Forbes Van Altena. Mr. Van Altena intends to build a home on a portion of that property which is now used exclusively for agricultural purposes.

Access to the Vogel parcel is by a joint driveway onto CTH N near its east boundary on a former railroad right-of-way. That driveway is shared by the next parcel to the east owned by the Van Altena Land Partnership. The partnership's access use has been approved for Private Entrance which permits construction of a home on that site. The current uses for the joint driveway therefore are one Field Entrance, one Private Entrance.

The request is to upgrade the access to the Vogel parcel to Private Entrance. The uses for the joint driveway therefore would become two Private Entrances. The Vogel's have granted permission for Mr. Van Altena to request upgrade of this access on their behalf.

Visibility at the access is adequate. Upgrading the use to the Vogel parcel will increase traffic from the driveway onto CTH N slightly. This increase should have negligible impact on the safety onto CTH N from either parcel.

RECOMMENDATION - Approval of the requested access use upgrade to two Private Entrances.

**SUBJECT:** Change of Use Request for an existing Controlled Access point along E. CTH N in Milton Township  
Parcel 6-13-72 (Forbes Van Altena) & 6-13-76.4/-76.2 (Van Altena Land Partnership LLC)

**DATE:** January 16, 2014

**Summary:**

The owners of Parcel 6-13-76 (Forbes Van Altena) and 6-13-76.4/-76.2 (Van Altena Land Partnership LLC) are requesting a Change of Use of an existing Joint Private/Field/Field Entrance to a Joint Private/Private/Private Entrance for potential residential construction on lots along Access Controlled E. CTH N.

Section 4.518 of the Rock County Code of Ordinances "County Trunk Highway Access Control Regulation" states, "Any point of access permitted under this ordinance shall be subject to review and approval by the Rock County Transportation (Highway Committee) and the Rock County, Planning and Zoning Committee, where these committees determine that there has been a change in use which will affect safe and efficient ingress and egress to, and use of a controlled access highway. This determination shall be based primarily on a significant change in the volume of traffic or type of vehicle using that point of access."

The Applicants have met with County Staff (Planning & Development/Public Works) to discuss the access situation for Parcels 6-13-67/-76.4/76.2. In those discussions Staff suggested the Applicant consider any potential future land use changes for their property. As a result, the owners of Parcels 6-13-76 (Field Entrance) & 6-13-76.4 (Field Entrance to E. CTH N through Parcel 6-13-76.2 by 30 foot Easement) considered potential residential construction. The proposal would add potentially 20 traffic movements per day via the residential development. The final resultant Joint Private Entrance/Private Entrance/Private Entrance servicing three parcels would generate 30 traffic movements per day. The speed limit is 55 miles per hour here and the next adjoining access to the west is 400 feet away (200 feet short of the required 600 feet).

The proposed change of use would impair movement for those vehicles traveling east and west. This section of the CTH system is designated a Rural Major Collector in the Rock County Comprehensive Plan. It is designed to service moderate sized communities and inter-area traffic generators and link those generators to nearby population centers or higher functionally classified roadways.

**Recommendation:**

Staff recommends denial of the request due to the potential decrease in functionality of E. CTH N. Additionally, safety is an issue with the proximity of the access to the west being only 400 feet away rather than the required 600 feet. Finally, the public investment in constructing and maintaining these roadways will be protected by limiting incompatible traffic.





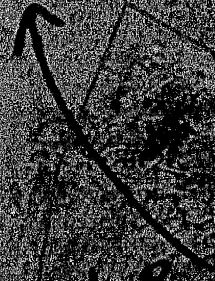

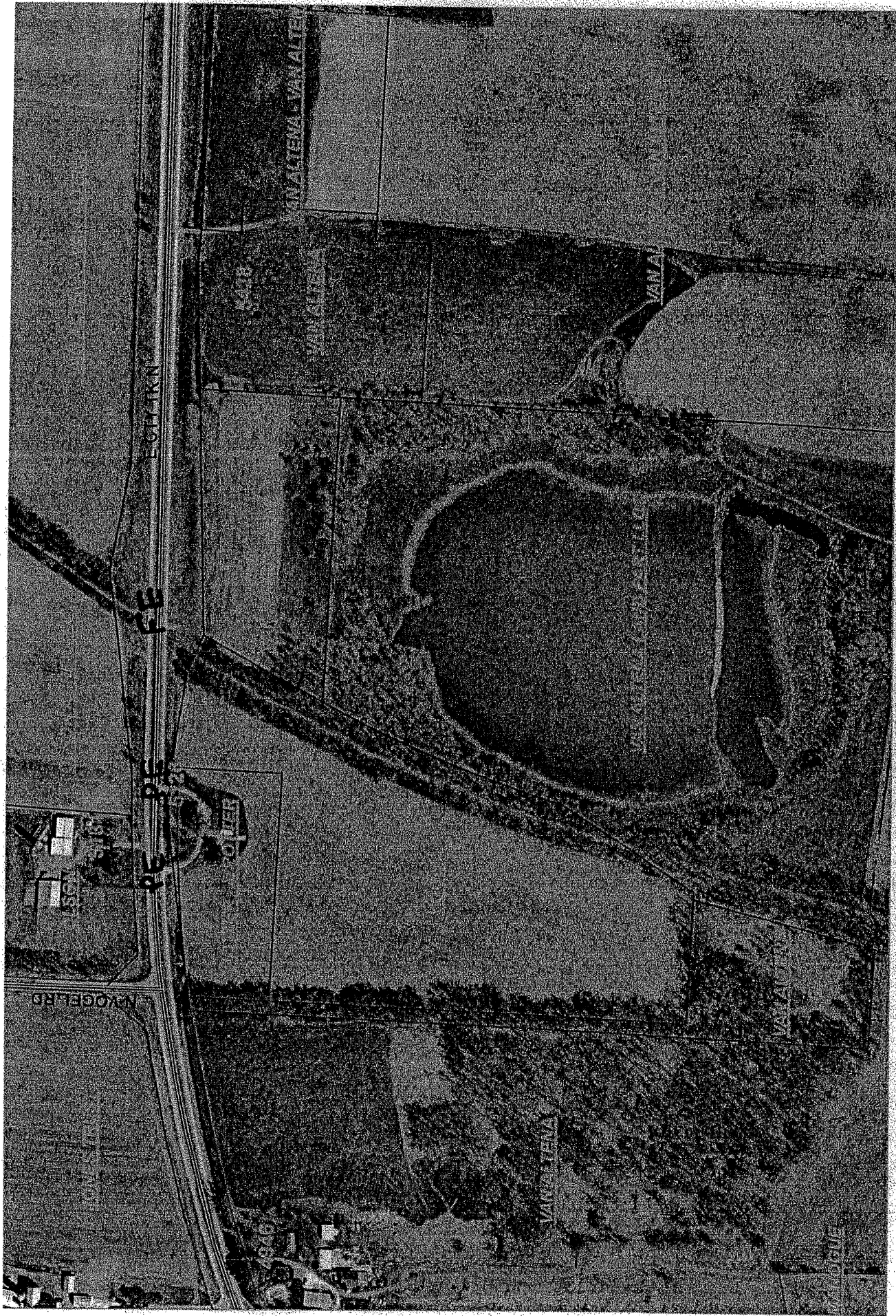
Sec. 10 Milton Township
