The meeting of the Rock County Housing Authority Committee was called to order at 9:00 a.m. on Wednesday, July 7, 2021. Chair Schulz presided. Members present: Billy Bob Grahn, Chair Kathy Schulz, Jason Heidenreich, and Michelle Ponkauskas. QUORUM PRESENT.

Andrew Baker reviewed his research regarding Housing Authorities in other Wisconsin counties. Roughly 10 counties have a Housing Authority. Three counties responded on how their Housing Authority was started and continues to be run. Suggestion from County Administrator Josh Smith is to have the Housing Authority request that the County Board fund hiring a consultant to develop the Housing Authority to meet the goals the Housing Authority wishes to do.

B. Overall Goals of the Housing Authority

Supervisor/Chair Kathy Schulz would like to make a recommendation regarding eviction and housing problems and move forward with drafting a resolution to obtain funding to provide resources to both tenants and landlords to stave off evictions.

BillyBob Grahn suggested requesting funding to hire a tenant resource officer for tenants and landlords to utilize.

Jason Heidenreich thinks the ideas above are good but reminded the committee that the Housing Authority is limited on what they can do. To implement the programs that are being suggested, changes in the authority the committee has needs to happen first.

Supervisor Kathy Schulz and Supervisor Shirley Williams have been working with County Administrator Josh Smith on a resolution to allocate some of the ARPA funds for eviction assistance.

BillyBob Grahn talked about ramping up the advertising to let the residents of Rock County know about the HOME funds available.

HOME fund ideas are to create different forgivable programs to help offset the cost of the total rehabilitation.

WHEREAS, the County of Rock has applied for and received Housing and Community Development Grants from Federal and State Agencies since 1978 for housing rehabilitation, down payment and emergency management assistance; and,

WHEREAS, the HOME Program Consortium, one source of Community Development funds, was created in 2001 by the County with the Cities of Beloit and Janesville; and,

WHEREAS, it was determined by Corporation Counsel, based on State Attorney General opinion, that counties do not have the legislative authority to administer HOME Consortium funds without the utilization of a Housing Authority; and,

WHEREAS, The Rock County Housing Authority was established by Board Resolution in June 2004 via authority found in 59.53(22) and 66.1201(4) Wis. Stats, to address unsafe inhabited dwellings, the shortage of decent, safe and sanitary rental units for low and moderate income citizens and the shortage of affordable dwellings available for those seeking to purchase a home; and,

WHEREAS, The Housing Authority consists of five members, including two County Board Supervisors, but is not a subcommittee of the County Board, receives only minimal staff support and funding in the Planning Department budget for conducting meetings, per diems and mileage, etc; and,

WHEREAS, the HOME program, including application review, contracting, project oversite and final approval, is primarily managed by a third party consultant and funded through administrative dollars available as via the HOME Consortium funds; and,

EXECUTIVE SUMMARY

This resolution authorizes providing funding to the Rock County Housing Authority to hire a consultant to develop a plan intend to address the desire of Authority members to expand the housing resources that are available to county citizens.

The Housing Authority was established in 2004 primarily to be the official administrator of HOME Consortium grant funds. It was determined at the time that the County as could not administer the funds directly. The Housing Authority, therefore, is not a subcommittee of the County Board, but does include two Board members and three citizens. Powers of the Housing Authority are authorized in 59.53(22) and 66.1201 Wisconsin Stats.

Since the establishment, the resources made available by the Authority have primarily been associated with the HOME Consortium eligible projects, i.e. rental rehab, single family home rehab and down payment assistance, all of which are applicable to low to moderate income citizens. The program is currently managed by a third-party consultant funded by the administrative dollars available through the grant program.

The Authority would like to expand housing resources available in the County beyond HOME eligible projects to address other needs, such as a shortage of low income housing. There are other State and Federal funding sources available, but navigating the options to come up with the best solution to the goals of the Authority would be best done by a private consultant with expertise on these matter. The Authority has no budget and no funds available and therefore requests that the County Board authorize a one-time payment to the Authority to proceed with an RFP and ultimately hiring of a consultant to complete a plan.

Allocating American Rescue Plan Act Funding to Create a Landlord-Tenant Mediation Program and Provide for Tenant Legal Representation

WHEREAS, the COVID-19 pandemic has had a negative effect on some individuals and families, including through job loss, and has exacerbated the difficulties of certain low-income individuals who were already facing economic challenges; and,

WHEREAS, eviction moratoria and other measures to keep household utilities operating that were put in place during the pandemic have kept many individuals and families safely in their homes, but the final eviction moratorium issued by the Centers for Disease Control has expired; and

WHEREAS, when this moratorium is removed, many individuals and families will have months' worth of back-rent due without the ability to pay, which will likely lead to the commencement of eviction proceedings; and,

WHEREAS, many landlords have not received rent payments while eviction moratoria have been in place, creating hardships for these business owners, who will legally be entitled to seek such past-due and future rent from tenants; and,

WHEREAS, statistics indicate that low-income and otherwise disadvantaged populations, who are more likely to face eviction, have also been less likely to have received a COVID-19 vaccine, creating a situation in which evictions may displace individuals into shared housing, shelters, or homelessness and thereby increase the likelihood of spreading COVID-19; and

WHEREAS, the American Rescue Plan Act (ARPA) has provided funding that can be utilized to address housing-related emergencies created or exacerbated by the COVID-19 pandemic; and

WHEREAS, while several community agencies may have sufficient funding currently from ARPA, Community Development Block Grant (CDBG), and/or other sources for eviction and utility aid, there may be a longer term need to address these issues with ARPA funding if currently available funds run out; and

WHEREAS, a current gap in the system is the absence of a program through which disputes between landlords and tenants can be mediated before the court system orders an eviction, particularly as both landlords and tenants may not have the necessary legal knowledge to result in the best outcomes for both without third-party support; and

WHEREAS, tenants, in particular, lack the resources necessary for representation in an eviction proceeding in court, putting them at a disadvantage; and

WHEREAS, Legal Action of Wisconsin can provide landlord-tenant mediation services and legal representation services for low-income individuals; and

WHEREAS, Everyone Cooperating to Help Others (ECHO) has expressed interest in providing an inkind donation of office space to support staff from Legal Action who are operating this program; and

WHEREAS, there is a need for a long-term strategy to address homelessness, transitional housing, and affordable housing, all of which have been exacerbated by the COVID-19 pandemic that will require future efforts of the County Board and that will be coming forward in subsequent resolution(s).

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this day of, 2021, does hereby allocate a total of \$444,000 (\$130,000 annually, including a prorated amount for 2021) of American Rescue Plan Act funding through 2024 to contract with Legal Action of Wisconsin to operate a landlord-tenant mediation program, through which those facing imminent eviction, and/or landlords with tenants unable to pay their rent, can utilize a neutral third-party to help resolve disputes as an alternative to eviction. This funding would provide for \$100,000 annually for a full-time attorney and \$30,000 annually for a part-time administrative assistant/outreach specialist, and would include all funding needed to support the work of those positions, such as wages, benefits, supplies, and equipment.
