ROCK COUNTY HOUSING AUTHORITY MEETING WEDNESDAY, September 29, 2021 – 9:00 A.M. Meeting was teleconferenced using ZOOM

The meeting of the Rock County Housing Authority Committee was called to order at 9:00 a.m. on Wednesday, September 29, 2021. Chair Schulz presided. Members present: Michelle Ponkauskas, Chair Kathy Schulz, Jason Heidenreich, BillyBob Grahn, and Supervisor Shirley Williams. QUORUM PRESENT.

5. **Informational Item:** HOME Consortium Update with Jennifer Petruzzello
Neighborhood & Community Services Director – City of Janesville

Jennifer Petruzzello presented an informative presentation on the history of the Consortium between City of Janesville, City of Beloit, and Rock County. Jennifer also updated on where the Consortium is standing at this time.

Supervisor Shirley Williams asked about the approval of the Annual Action Plan that is prepared by City of Janesville for the Consortium. Jennifer explained that the Janesville City Council approves the plan.

Supervisor Kathy Schulz asked how the plan has been handled over the prior year and a half as the Housing Authority hadn't been meeting. Jennifer explained that the Consortium members contributed information for the plan to be created.

Jason Heidenreich asked if there are any requirements in the HOME program to contract with local contractors instead of the outside contractors that worked on River Flats? Jennifer explained that the contractor requirements are based on HUD requirements and not a local decision.

Supervisor Shirley Williams asked if the slideshow presentation could be shared with the members of the committee. Andrew will forward to committee members.
