## Rock County Department of Public Works Division of Highways – Issue Paper

ISSUE - Selection and Award of the 2014/2015 Local Bridge Inspections

**DISCUSSION** - The local government agencies in the United States are required by Federal Law to inspect their local bridges at least once every two years. Because of the type, location or condition of some of these bridges, they must be inspected every year. Rock County acts as the lead agency for soliciting and hiring a qualified consulting engineering firm for the County's bridges, as well as most of the towns in the County. Only the cities of Evansville, Edgerton, Beloit and Janesville perform their own or select their own inspection consultants.

Rock Co. DPW staff solicited cost proposals from all firms on its 2014 Roster of Eligible Consultants. Seven firms responded. A summary of their proposals is attached. The request for proposal also included a solicitation for an hourly and mileage rate to provide Bridge Project Management Services on behalf of the County for the two-year period. Jewell Associates Engineers is the current consultant for both of these services for 2012-2013.

**RECOMMENDATION** - Select and award a contract to the lowest proposer, Jewell Associates Engineers for a fee of \$24,520. Further retain them for another 2-year cycle at the hourly and mileage rates shown in the proposal as Rock County's Bridge Project Manager.
