At a meeting of the Supervisors of the said town of Avon agreeably to notice posted according to law and having personally examined and heard all reasons offered for or against the laying of the highway in said notice proposed it is ordered that a highway be laid out in said town of the width of our rods, the center line of said highway to commence at the centre of section number thirty-one (31) of said town thence running east on the line between the northeast quarter and Southeast quarter of said section to the east side or line of the same section, intersecting the highway running north from the State line to Sugar River Bridge. 1867 Levi J. Waller Release of Damages on Sec. 31 \$60.00

July 25 whereas a highway having been laid out by the Supervisors of the town of Avon, County of Rock by an order bearing date the 3rd day of June 1867 described as follows, commencing at the centre of Section No. thirty-one (31) thence running East on the line between the North East quarter and South East quarter of said section to the east side of the line of the same section intersecting the highway running North from the state line to Sugar River bridge, which road passes through certain lands owned by me described as follows; viz the East half of the South East quarter of Sec. No. thirty-one (31) - Now therefore know all men by these presents that I Levi J. Waller for value received do hereby release all claims to damages sustained by me by reason of laying out and opening said highway through my said lands above described. In witness whereof I have hereunto set my hand and seal this 26th day of July A. D. 1867.
