At a meeting of the Coms. of Highway of the town of Newark having met and deliberated on the subject embraced in this order - it is ordered and determined by said Coms. to alter-part of the road that runs north past the dwelling of John S. Campbell commencing at the Southeast corner of Sect. 22 and at South West corner of Sec. 23, thence running north the section line to be the center of the road until the quarter post West side of said Section 23 and to discontinue that part of the road that angles round by the brook all that becomes useless and unnecessary by said alteration.
