Records of the Town of Porter 1870

Page 20 Application for laying of Highway.

Whereas upon the application of six freeholders residing in said town of Porter, for the laying out of a highway, as hereinafter described. we the undersigned Supervisors of said town, did on the 27<sup>th</sup> day of April 1870 make out a notice and fix therein a time and place at which we would meet and decide upon such application and did meet on the 7<sup>th</sup> day of May 1870 at 2 o'clock in the afternoon of said day at the house of Ben Soden, it being the time and place fixed by us in said notice, and having first been satisfied that the notice aforesaid had been duly given, five days previous to said meeting to the occupants of the land through which said highway passes, and had also been posted up in three public places ten days previous to our said meeting, we did then and there proceed personally to examine said highway and did hear all reasons that were offered for or against the laying out the same, and did decide upon such application and it being our opinion that the public good will thereby be promoted did decide to lay out said Highway as hereinafter described: Beginning at a point in the center of the highway that runs Southeasterly through the N.W. ¼ of Sec. 2 said point being westerly and near the bridge crossing the outlet of a marsh on said ¼ section, thence North easterly on the westerly side of said marsh on a line as near direct as good ground for a road will admit to the ¼ post on the North line of said Section.

Now therefore pursuant to said application, we the said Supervisors do hereby order and determine that a highway be and the same is hereby laid out, as above described, said highway to be four rods wide.

Made and signed by us this 7<sup>th</sup> day of May 1870.
