

ORDER FOR HIGHWAY

BAKKE R

At a meeting of the supervisors of the Town of Beloit held pursuant to previous public notice at the office of the Town Clerk in Beloit on the 11th day of July 1854 to consider the petition of John Clinchy and others in relation to a certain road therein named and being satisfied by the affidavit of Jacob Lund that the notice required by law had been given and after hearing the objections to laying said road and having previous examined the same, decided to lay said road. We do therefore hereby order and determine that a road or highway four rods in width be laid, the center of which shall be the West half quarter line of Section 5: Commencing at a point in the South line of the Town of Rock where the road laid out by the supervisors of the Town of Rock terminates and running South on said line to the road running East to Rock River; thence 80 rods West on a road laid out and running from said Rock River West on the quarter line in said Town of Beloit; thence running South on the section line between Section 5 and 6 to the South-east corner of Section 6.

ORDER FOR HIGHWAY

At a meeting of the supervisors of the Town of Beloit held pursuant to previous public notice at the office of the Town Clerk in Beloit on Tuesday the 11th day of July 1854 to consider the petition of Gorgus Seberson and others in relation to laying out a certain road therein named and being satisfied by the affidavit of Gorgus Seberson that the proper notices had been given and after hearing the objections and considering the remonstrance presented against said road and having deliberation, hereby order and determine that the center of a road four rods wide shall be and is hereby laid commencing at the center of Section 8 and running due North one mile to the center of Section 5 where it intersects a road leading West from Rock River; also another road the center of which shall be the section line between Sections 5 and 8 and 6 and 7 commencing at the quarter post in the South line Sec. 5 and running West one mile to the quarter post in the South line of Sec. 6; thence North one mile to the quarter post in the North line of said Sec. 6.

At a meeting of the supervisors at the house of E. N. Baldwin in said town on the 28th day of February A.D. 1855 of eleven o'clock of said day and being satisfied by affidavit and other wise that the proper notices had been given and having examined and deliberated upon the subject herein embraced, it is ordered and determined by the said supervisors that a highway of the width of four rods be laid out in said town. The centerline of which said highway shall be as follows: Commencing at the quarter section post in the East line of Section 6 in said town and running East on the quarter section lines through Sections 4, 3 and 5 to the road leading from Beloit to Afton which said road is near to and West of the Beloit and Madison Railroad and is the East line of said Section 3.
