To the supervisors of the Towns of Rock and Beloit, County of Rock.

We the undersigned freeholders residing in the Towns of Rock and Beloit do hereby make application to you to lay out a highway upon the line between said towns of Rock and Beloit as follows to note: Commencing at the Southwest corner of Sec. 35, Town of Rock and the Northwest corner of Sec. 2, Town of Beloit; thence running West on the line between said Towns of Rock and Beloit terminating at the Beloit and Janesville Road, South of the Village of Afton at the Northwest corner of Section 3, Town of Beloit and the Southwest corner of Sec. 35, Town of Rock said line running between the South half of the Southeast quarter and the Southwest quarter of Section 34, Town of Rock and the North half of the North half of the Northeast quarter and the North half of the Northwest quarter of Section 3, Town of Beloit. Said lands owned or occupied by Crossman, Sharpe and Bowen.

Said highway is described in the application as follows: Commencing at the Southwest corner of Sec. 35, Town of Rock and the Northeast corner of Sec. 2, Town of Beloit; thence running West on the line between said towns terminating at the Beloit and Janesville Road, South of the Village of Afton at the Northwest corner of 3 (Sec.), Town of Beloit and the Southwest corner of Sec. 34, Town of Rock. Said line running between the S. 1/2 of the S.E. 1/4 of or and the S.W. 1/4 of Section 34, Town of Rock and the North 1/3 of the N. 1/2 of the S.E. 1/4 and the N. 1/2 of the N.W. 1/4 of Sec. 3, Town of Beloit. Said lands assessed to Crossman, Pratt, and Bowen and also lands occupied as right-of-way by the Chicago and Northwestern railway.
