ORDER FOR HIGHWAY

Application having been made on the 22nd day of January 1878 to the undersigned supervisors of the Town of Beloit in the County of Rock, Wisconsin by six freeholders of said town for a highway to be laid out as follows: Commencing at a point in the Beloit and Janesville River Road on the East side of Rock River where the quarter section line crosses said road,; thence running East on said quarter line to the quarter stake or post between Sections 23 and 24; thence East on the quarter section line through Section 24 to the town line road leading from Beloit to Janesville.

Notice is therefore, hereby given that we, the undersigned supervisors of said town, will meet on the 23rd day of February at one o'clock in the afternoon at the house of Archibald Cranston in said town and decide upon such application. Dated at Beloit this 12th day of February 1878.

Whereas upon the application of six freeholders residing in said town of Beloit for the laying out of a highway as hereinafter described. We the undersigned supervisors of said town did on the 21st day of February 1878 make out a notice and fix therein a time and place at which we would meet and decide upon such application and did meet on the 23rd day of February 1878 at the house of Archibald Cranston it being the time and place fixed by us in said notice and having first been satisfied that the notice aforesaid had been duly given five days previous to the time of our said meeting to the occupant of the land through which said highway passes and had also been posted up in three public places in said town ten days before the time of our said meeting in the manner required by law, we did then and there proceed to examine personally said highway and did hear all reasons as that were offered for or against laying out the same. And did decide upon such application and it being our opinion that the public good will thereby be promoted, did decide to lay out said highway as hereinafter described.

Now, therefore, pursuant to said application. We the said supervisors do hereby order determine that a highway be and the same is hereby laid out as follows to wit:

Commencing at the point in the Beloit and Janesville River Road on the East side of Rock River where the quarter section line crosses said road, thence running East on said quarter line to the quarter stake or post between Sections 23 and 24; thence East on the quarter section line through Section 24 to the town line road leading from Beloit to Janesville, the same being an accurate survey thereof caused by us to be made.

The line of said survey is the center of said highway and the same is laid out of the width of four rods.
