

Be it known that we, Clark Nye, Overseer of Highway Dist. No. 8 and A. F. Hollister, Overseer of Highway Dist. 9 both of the Town of Beloit being called upon by A. Hulverson met together on the 19th day of October 1860 and proceeded to view and divide the line fence between said Hulverson and Arna Gulackson now living on the N.W. 1/4 of the N.W. 1/4 of Section 19, Town 1, Range 12 as follows to wit: That A. Hulverson shall erect and maintain the line fence on said described land as follows to wit; namely the West one-half on the South line and the South half on the East line. And Arna Gulackson the East one-half on the East line of said land. And that sixty days from this date is granted to each said named persons to build said fence. And further the Arna Gulackson is entitled to all the fence now standing on the South line of the above described land except nine rods, the East end of the same which belongs to A. Hulverson and is to removed.

Whereas a highway has been laid out by the supervisors of the Town of Beloit and County of Rock described as follows: Beginning at the center of Section 8 in said town and running thence West along said quarter line through Section 8 and West along said quarter line through Section 8 and 7 to the Beloit and Madison Road according to an order for said purpose bearing date October 16th, 1860 and which said highway passes through lands owned and occupied by Hugh McGavock, viz a strip of land two rods in width taken off the South side the whole length thereof of the N.W. 1/4 of Section 8, Town 1, Range 12 East also through land owned by J. A. Morse, viz two rods in width off the whole length of the North side of the East half of the S.W. 1/4 of said Section 8 - also through land owned by J. Mattby, viz two rods in width off the whole length of the North side of the West half of the Southwest quarter of said Section 8. also through land owned by C. Stoddard viz, two rods in width off the whole length of the North side of the East half of the S.E. 1/4 of Section 7, said town and range 12- also through land owned by O. R. Bass, viz, two rods off the whole length of the South side of the East half of the N.E. 1/4 of said Section 7 also the land owned by R. Irish, viz two rods in width taken off the whole length of the North side of the West half of S.E. 1/4 of said Section 7-also through lands owned by W. Morse, viz two rods in width off the whole length of the South side of the West half of the N.E. 1/4 of said Sec. 7. And that the above named persons excepting Hugh McGavock appealed from the award of damages by said supervisors to a jury of appraisers and the appraisal of said jury exceeding the amount of the award by the Supervisors.
